WADA's Research Package for Anti-Doping Organisations

WADA has published a [research package](#) with a compilation of surveys with which the attitudes and beliefs of athletes towards doping can be tested. This research package is an evaluation tool for education and prevention programmes.

This valuable material can certainly help ADOs assessing the effectiveness of their programs. It also contains useful information on how to manage and interpret statistical data. The more ADOs that implement this standardized approach, the better the comparable international data that will enable all

NADOs, RADOs and international sport organisations to put into place more effective campaigns to deter doping. We invite you to review it and make use of it.

Definition of Clean Sport to measure Anti-Doping

Recently, at an international anti-doping conference in Spain ("[Sport, Doping and Society](#)", hosted by iNADO Member the Spanish Agency for the Protection of Health in Sport) it was argued that measuring the success of anti-doping without a clear definition of "clean sport" is problematic. Without such a definition, how can you measure success? Few ADOs possess an operative definition of "clean sport."

[Drugfree Sport New Zealand](#) is one exception. It states: *A culture of clean sport means that sport is fair and competitive. It allows no room for cheats who seek to enhance their performance by taking drugs or using banned methods.*

Furthermore in its view, clean sport means athletes:

- compete on a level playing field.
- are rewarded for their hard-work, talent and skills
- value the spirit of sport
- respect and look after their bodies and their health
- follow the anti-doping rules
- understand the importance of a drug testing regime to catch cheats and protect clean athletes.

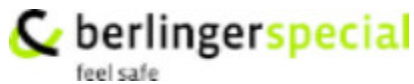
