### IOC DISCIPLINARY COMMISSION

#### RECOMMENDATIONS

#### REGARDING MS MARION JONES BORN ON 12 OCTOBER 1975, ATHLETE, UNITED STATES OF AMERICA

1. Ms Marion Jones competed in the 2000 Sydney Olympic Games in the following events in the sport of athletics:
  - 100m, where she placed 1<sup>st</sup> ;
  - 200m, where she placed 1<sup>st</sup> ;
  - 4 x 400m relay, where the team she was on placed 1<sup>st</sup> ;
  - 4 x 100m relay, where the team she was on placed 3<sup>rd</sup>; and
  - Long jump, where she placed 3<sup>rd</sup>
2. Ms Jones competed in the 2004 Athens Olympic Games in the following event in the sport of athletics:
  - Long jump, where she placed 5<sup>th</sup>.
3. Following allegations made by Mr Victor Conte in relation to doping offences being committed, in particular in relation to the 2000 Sydney Olympic Games, the IOC President, by letter dated 7 December 2004, established a Disciplinary Commission to investigate the consequences of such allegations and the activities of the Balco Laboratory in relation to the Olympic Games.
4. The IOC Disciplinary Commission is comprised of Dr Thomas Bach (Chairman), Mr Denis Oswald (member), Mr Sergey Bubka (member) and Me François Carrard (Secretary).
5. Based on the proceedings initiated by the United States Department of Justice ("USDJ") in relation to the Balco Case, the United States Anti-Doping Agency ("USADA"), initiated its own disciplinary proceedings.
6. The IOC has repeatedly requested the United States Olympic Committee ("USOC") and USADA to keep the IOC fully informed and to provide to the IOC all relevant documentation that could contribute to the establishment of any anti-doping rule violations in relation to the Olympic Games. The documentation received to date by the IOC is not sufficient to enable it to take any action in relation to the Balco case, except as follows.
7. The IOC received in October 2007, a document, entitled "*Acceptance of Sanction*", which had been signed by Ms Jones on 8 October 2007. Pursuant to such document, Ms Jones, amongst other things:
  - (i) acknowledged that she "*used the prohibited substance known as the "clear" prior to, during and after the 2000 Olympic Games...*";
  - (ii) accepted a "*two (2) year period of ineligibility [...] beginning on [8 October 2007]*";
  - (iii) accepted a "*disqualification of all competitive results obtained on or subsequent to September 1, 2000, including forfeiture of all medals, results, points and prizes*"; and

- (iv) accepted “a two (2) year period of ineligibility, beginning on [8 October 2007], from participating or coaching in U.S. Olympic [...] Trials, being a member of any U.S. Olympic [...] Team [...]”.

A copy of this document is attached hereto as **Annex 1**.

8. Ms Jones, via the USOC, returned to the IOC the five medals that she won at the 2000 Sydney Olympic Games.
9. By letter dated 28 November 2007, the President of the IAAF informed the President of the IOC that the IAAF Council confirmed the following consequences (amongst others) in the case of Ms Jones:
- *A 2-year period of ineligibility beginning on the date of her acceptance of sanction dated 8 October 2007, i.e. until 7 October 2009.*
  - *Disqualification of Ms Jones from all competitions on or subsequent to 1 September 2000;*
  - *Annulment of all her individual competitive results on or subsequent to 1 September 2000;*
  - *Annulment of the results of all relay teams in which she competed in IAAF competitions on or subsequent to 1 September 2000; and*
  - *Forfeiture and return of all awards and medals obtained in relation to the above competitions.”*
10. In view of USADA and the USDJ apparently not yet being in a legal position to give to the IOC full access to the documentation concerning the Balco case, and given that the Balco investigation is still ongoing, the IOC is not yet in a position to know whether all the athletes that may be involved in such case have been identified. Therefore, the Disciplinary Commission believes that no decision should be taken at this point in time regarding the rankings of the athletes who placed behind Ms Jones.
11. The Disciplinary Commission notes the fact that Ms Jones blatantly lied for a number of years concerning her taking prohibited substances. The Disciplinary Commission also notes that, after being under much pressure to do so, Ms Jones has recently admitted to having committed anti-doping rule violations.
12. The Disciplinary Commission considers that, in addition to the sanctions recommended in relation to the 2000 Sydney and 2004 Athens Olympic Games, sanctions should also be imposed against Ms Jones in relation to future Olympic Games. The Disciplinary Commission is of the view that Ms Jones should not be eligible for the 2008 Beijing Olympic Games in any capacity – i.e. she should not receive accreditation as an athlete, coach, official, journalist or otherwise. With respect to Olympic Games subsequent to the 2008 Beijing Olympic Games, the Disciplinary Commission recommends that the IOC reserves its rights to consider possible further sanctions against Ms Jones, pending the outcome of the Balco investigation.
13. As for the consequences of Ms Jones’ anti-doping rule violations in relation to the relay teams in which she participated, this will be addressed, in due course, in a separate recommendation by the IOC Disciplinary Commission.

CONSIDERING the above, and pursuant to the Olympic Charter and the relevant anti-doping rules:

**THE DISCIPLINARY COMMISSION OF THE  
INTERNATIONAL OLYMPIC COMMITTEE  
RECOMMENDS TO THE IOC EXECUTIVE BOARD**

- I The athlete Ms Jones be disqualified from the following events in which she competed at the 2000 Sydney Olympic Games in the sport of athletics:
- 100m, where she placed 1<sup>st</sup>;
  - 200m, where she placed 1<sup>st</sup>;
  - 4 x 400m relay, where the team she was on placed 1<sup>st</sup>;
  - 4 x 100m relay, where the team she was on placed 3<sup>rd</sup>; and
  - Long jump, where she placed 3<sup>rd</sup>.
- II The United States Olympic Committee ("USOC") be requested to return to the IOC the diplomas awarded to Ms Jones in the above-noted events (it being acknowledged that the USOC has already returned to the IOC the medals won by Ms Jones in such events).
- III Ms Jones be disqualified from the following event in which she competed at the 2004 Athens Olympic Games in the sport of athletics:
- Long jump, where she placed 5<sup>th</sup>
- IV The USOC be requested to return to the IOC the diploma awarded to Ms Jones in the above-noted event.
- V The International Association of Athletics Federations ("IAAF") be requested to take the appropriate steps so that its records reflect the above.
- VI Ms Jones be ineligible for the 2008 Beijing Olympic Games in any capacity.
- VII Ms Jones be notified that the IOC reserves its rights to consider possible further sanctions against her, in particular permanent ineligibility for all future Olympic Games in any capacity, pending the outcome of the Balco investigation.
- VIII The issue of adjusting the rankings of the athletes that finished behind Ms Jones in the individual events referred to above be addressed by the IOC Executive Board in due course, pending the IOC receiving full access to the documentation concerning the Balco case.

**REGARDING MS MARION JONES  
BORN ON 12 OCTOBER 1975, ATHLETE, UNITED STATES OF AMERICA**

UPON CONSIDERING the attached Recommendations of the IOC Disciplinary Commission dated 12 December 2007, and pursuant to the Olympic Charter and the relevant anti-doping rules,

**THE IOC EXECUTIVE BOARD OF THE  
INTERNATIONAL OLYMPIC COMMITTEE  
DECIDES**

- I The athlete Ms Jones is disqualified from the following events in which she competed at the 2000 Sydney Olympic Games in the sport of athletics:
  - 100m, where she placed 1<sup>st</sup>;
  - 200m, where she placed 1<sup>st</sup>;
  - 4 x 400m relay, where the team she was on placed 1<sup>st</sup>;
  - 4 x 100m relay, where the team she was on placed 3<sup>rd</sup>; and
  - Long jump, where she placed 3<sup>rd</sup>.
- II The United States Olympic Committee ("USOC") is requested to return to the IOC the diplomas awarded to Ms Jones in the above-noted events (it being acknowledged that the USOC has already returned to the IOC the medals won by Ms Jones in such events).
- III Ms Jones is disqualified from the following event in which she competed at the 2004 Athens Olympic Games in the sport of athletics:
  - Long jump, where she placed 5<sup>th</sup>
- IV The USOC is requested to return to the IOC the diploma awarded to Ms Jones in the above-noted event.
- V The International Association of Athletics Federations ("IAAF") is requested to take the appropriate steps so that its records reflect the above.
- VI Ms Jones is ineligible for the 2008 Beijing Olympic Games in any capacity.
- VII Ms Jones be notified that the IOC reserves its rights to consider possible further sanctions against her, in particular permanent ineligibility for all future Olympic Games in any capacity, pending the outcome of the Balco investigation.
- VIII The issue of adjusting the rankings of the athletes that finished behind Ms Jones in the individual events referred to above be addressed by the IOC Executive Board

in due course, pending the IOC receiving full access to the documentation concerning the Balco case.

IX This Decision shall enter into force immediately.
