Brussels, 05 June 2013

The CISM Discipline Commission was called up for an official meeting at the CISM General Secretariat on the 05th of June 2013, upon request of the CISM Secretary General.

The CISM Discipline Commission was requested to analyze the case of a positive doping result occurred during the Ski Orienteering competitions held within the framework of the 2nd Military Winter Games, in Annecy, France, from 25 to 29 March 2013.

The CISM Discipline Commission:

Considered the Analysis Result Record sent by the French Anti-Doping Agency, which states that the sample code 2697857 showed an adverse result for **carphedon**, classified as "S6. Stimulants" at the WADA Prohibited List, version 2013;

Considered the Doping Control Form confirming that the bottle number 2697857 belongs to NATALIA TOMILOVA, from the Russian Delegation;

Considered the letter sent by the Russian Delegation, stating that the athlete does not want to proceed with the Sample B Analysis, dated 31 May 2013;

Considered the athlete declined her presence at, or send her representative to the hearing panel, on 05 June 2013;

Considered the letter of NATALIA TOMILOVA, dated 31 May 2013, explaining her reasons and the medicines she took prior to the test, and in which she agrees with the doping test results.

The CISM Discipline Commission, after analyses of the records and files available at the CISM General Secretariat, taking into consideration the WADA Code, the CISM Anti-doping Regulations, the International Orienteering Federation Anti-doping Regulations (Article 11.2.1 and 11.2.2) as well as NATALIA TOMILOVA's letter, formulates the following conclusion and sanctions:

1. The athlete is considered to have committed an anti-doping rule violation during the above mentioned CISM sport event, on March 26 and 27, 2013, in France;

2. The athlete is suspended from participating in any CISM event for a period of 2 (two) years, starting from the date of the Doping Control, 26^{th} of March 2013;

3. The Russian Delegation is to arrange the return of her individual gold medal to the CISM General Secretariat not later than 15 August 2013. After this date, the CISM SG will reallocate the medals amongst the medal winners;

4. According to article 10.8 of WADA Code, the Russian Delegation is to assure the return of the relay silver medals to the CISM General Secretariat not later than 15 August 2013. After this date, the CISM SG will reallocate all medals amongst the medal winners.

The CISM Discipline Commission decided to communicate the case and the current decisions to the responsible authorities: WADA, International Orienteering Federation, Russian Anti-doping Agency, French Delegation to CISM, Russian Delegation to CISM, and NATALIA TOMILOVA (through Russian Delegation).
