DECISION

No. 39/ 27.10.2010

The *Hearing Commission for athletes and their support personnel who violated the anti-doping rules*, summoned on 27.10.2010, 10:00 H, at the National Anti-Doping Agency official seat in Bucharest, 37 – 39 Basarabia Bvd., sector 2, regarding the final decision of the athlete **COLEMAN YAMENE JAVE**, nationality: American, registered to **Perla Harghitei Miercurea Ciuc Basketball Club**, residing in Romania, Miercurea Ciuc, 44 Revolutiei Street, Harghita County establishes:

Following the out of competition doping control on 14.09.2010 conducted on sport discipline basketball, conducted in Bucharest, the analytical result of the sample of the athlete **COLEMAN YAMENE JAVE** with the code number **1941614A**, indicated the presence of hydrochlorothiazide, the substance is included in the class *S5.Diuretics and other Masking Agents* of the 2010 Prohibited List.

The *Hearing Commission for athletes and their support personnel who violated the anti-doping rules* summoned on 12.10.2010, where the athlete stated that he was suffering from hypertension and doctors from United States of America have prescribed him hydrochlorothiazide. At the same time, the athlete stated that this affection is inheritable, his mother and his grandmother both suffered from the same affection. To support the things he stated, the athlete presented medical documents from USA and a Medical Consultation Sheet from Sports Medicine Service of Miercurea Ciuc Policlinic, Harghira County. The athlete stated in Doping Control Form at Section *Declaration of Medication Use* that he used medication for

hypertension. Also, the *Hearing Commission* noticed that until the athlete arrived in Romania, in September 2010, he played at Troy University as an amateur player. Also on this occasion, the athlete presented a retroactive TUE request for hydrochlorothiazide. The athlete was provisionally suspended from that date.

The *Hearing Commission for athletes and their support personnel who violated the anti-doping rules* reviewed the documents within the file, namely the analysis bulletin no. 506/22.09.2010 of Bucharest Doping Control Laboratory, the athlete's statement, the medical documents presented, retroactive TUE granted and in compliance with the legal provisions on national and international level:

DECIDES

Elimination of the provisional suspension of the athlete **COLEMAN YAMENE JAVE** from any sport activity, as result of the retroactive TUE granted, the athlete was suffering from hypertension since 2008, as appear from the medical document presented on 12.10.2010 at the hearing meeting.

His action will be considered first anti-doping rule violation and the sanction will be a reprimand and no period of Ineligibility from future events.

The decision starts on the date of its related– 27.10.2010.

The athlete is not included in Registered Testing Pool of Romanian Anti-Doping Agency.

The decision shall be communicated to the athlete, Perla Harghitei Miercurea Ciuc Basketball Sport Club, Romanian Basketball Federation, National Authority for Youth and Sport, Romanian Olympic and Sport Committee, relevant international federation and the World Anti-Doping Agency.

Romanian Basketball Federation has the obligation to apply the provisions of the current decision and to comply with the legal provisions in force pursuant to the provisions of the article 65, paragraph (1) of the Law 227/2006 republished.

At another doping control the athlete must indicate clearly the drugs which he takes at doctor's prescription for hypertension and also that he has a TUE for the active substance.
