

## GUVERNUL ROMÂNIEI AGENȚIA NAȚIONALĂ ANTI-DOPING

## DECISION No. 12/03.05.2011

The Hearing Commission for athletes and their support personnel who violated the anti-doping rules, summoned on 03.05.2011, 10:00 H, at the National Anti-Doping Agency official seat in Bucharest, 37 – 39 Basarabia Bvd., sector 2, regarding the hearing of the athlete **Bratiloveanu Adrian Marian**, registered to **CSS3 CSA Steaua Bucharest**, residing in Bucharest, 9 Valea Lunga Street, Bl. 144, Sc. A, Appt. 14, District 6 establishes:

Following the doping control on 02.04.2011 conducted on sport discipline rugby, on the occasion of National Championship U19, C.S.S3 CSA Steaua Bucharest - Rolling Stock for Railway Transport Metrorex Bucharest Technical College match, conducted in Bucharest, the analytical result of the sample of the athlete **Bratiloveanu Adrian Marian** with the code number **1966487A**, indicated the presence of the prohibited substance epimethendiol, metabolite of methandienone the substance is included in the class S1.1 a of the 2011 Prohibited List (Exogenous Androgenic Anabolic Steroids).

The *Hearing Commission* noted that the athlete was not present at the hearing meeting despite the fact he had been legally notified. The case was reviewed in absence of the athlete taking into account that the convocation procedure of the athlete was respected, the evidence was the receiving document of the Notification by the athlete, the presence of Dr. Alin Popescu as Observer of Romanian Rugby Federation and the presence of Mr. Octavian Corneliu as coach of the athlete. It also noted that the athlete did not send any statement or request for the hearing to be postponed.

The Hearing Commission for athletes and their support personnel who violated the anti-doping rules reviewed the documents within the file, namely the analysis bulletin no. 215/15.04.2011 of Bucharest Doping Control Laboratory, taking into account the legal provisions on national and international level:

## **DECIDES**

The ineligibility of the athlete **Bratiloveanu Adrian Marian**, registered to **CSS3 CSA Steaua Bucharest**, for a period of two (2) years from any sport activity, pursuant to the provisions of art. 38 of Law 227/2006 regarding prevention and fight against doping in sport republished with the following amendments, as the athlete violated the provisions of article 2, paragraph (2), letter a) of the mentioned law.

The provisional suspension period begins to run from the date of the current decision.

Pursuant to the provisions of art.45 of the mentioned law, during the ineligibility period, the athlete has the obligation to submit his whereabouts information to the Agency. Aiming to reintegrate in sport activity, during the ineligibility period, the athlete has to undergo to four no advance notice doping testing, one of them at the moment when the sport activity is started again. When the athlete firstly retires from sport activity during the ineligibility period and then he requests to be reintegrated in sport activity, he won't be reintegrated until he informs the Agency and no advance notice doping testing is performed during a period of time equal to the ineligibility period remained when he retired.

The decision may be appealed by the athlete to the Appeal Commission besides National Anti-Doping Agency in 21 days since it notification, this became mandatory after the expiration of the mentioned period.

The decision shall be communicated to the athlete, **CSS3 CSA Steaua** Bucharest, Romanian Rugby Federation, National Authority for Youth and Sport,

Romanian Olympic and Sport Committee, relevant international federation and the World Anti-Doping Agency.

Romanian Rugby Federation has the obligation to apply the provisions of the current decision and to comply with the legal provisions in force pursuant to the provisions of the article 71 of the Law 227/2006 republished.

Pursuant to the provisions of art.36, paragraph (4) of Law 227/2006 regarding prevention and fight against doping in sport, republished, the above-mentioned institutions are required to maintain confidentiality of the information communicated until the public disclosure of the case.
