Summoned on 05.12.2011, 10:00 H, at the National Anti-Doping Agency official seat in Bucharest, 37 – 39 Basarabia Bvd., sector 2, regarding the hearing of the athlete **Enciu Ionut Cristian**, registered to **Farul Constanta Sport Club**, residing in Constanta, 63 Comarnic Street establishes:

Following the doping control on 07.10.2011 on the occasion of National Weightlifting Championship, conducted in Onesti, the analytical result of the sample of the above-mentioned athlete with the code number **1981309A**, indicated the presence of **metabolite of Methandienone**: 18-nor-17 α -methyl-17 β -hydroxymethyl-androst-1,4,13-trien-3-one; **metabolite of Fluoxymesterone**: 9 α -fluoro-18-nor-17, 17-dimethyl-androsta-4, 13-dien-11 β -ol-3-one, **metabolites of Methyltestosterone**: 17 α -methyl-5 α -androstane-3 α , 17 β -diol and 17 α -methyl-5 β -androstane-3 α , 17 β -diol. All these substances are included in the class S1.1.a of the Prohibited List (Exogenous Anabolic Androgenic Steroids).

The *Hearing Commission for athletes and their support personnel who violated the anti-doping rules* summoned on 21.11.2011 where the athlete was not present despite the fact he had been legally notified and he did not send a written statement. Also the representative of Farul Constanta Club did not answer to the notification sent by the Hearing Commission beside RANAD.

The Hearing Commission summoned on 05.12.2011 to establish a final decision. On the request of the Hearing Commission from 21.11.2011 at the hearing meeting was present Mr. Basturea Sorin Stefan, deputy director of Farul Constanta Sport Club, he was authorized by Mr. Ilie Floroiu, president of Farul Constanta Sport Club. The athlete was not present at this hearing meeting despite the fact he had been legally notified and he did not send a written statement. The deputy director stated that educative activities to prevent doping in sport were carried out within the Club and he agreed to establish a final decision in the absence of the athlete. The athlete won a golden medal and a silver one in the National Weightlifting Championship, conducted in Onesti.

Also he stated that the athlete left the country and it was impossible to contact him.

The *Hearing Commission for athletes and their support personnel who violated the anti-doping rules* reviewed the documents within the file, namely the analysis bulletin no. 752/31.10.2011 of Bucharest Doping Control Laboratory, the fact that the athlete was not present at any hearing meeting, taking into account the legal provisions on national and international level:

DECIDES

The ineligibility of the athlete **Enciu Ionut Cristian**, registered to **Farul Constanta Sport Club**, for a period of two (2) years, pursuant to the provisions of art. 38 of Law 227/2006 regarding prevention and fight against doping in sport republished, with further amendments, as the athlete violated the provisions of article 2, paragraph (2), letter a) of the mentioned law.

The ineligibility period begins to run from the date of the current decision.

The provisional suspension period, from 21.11.2011 to 04.12.2011, shall be credited against the ineligibility period, pursuant to the article 44 paragraph (2) of the mentioned law.

Pursuant to the provisions of art.45 of the mentioned law, during the ineligibility period, the athlete has the obligation to submit his whereabouts information to the Agency. Aiming to reintegrate in sport activity, during the ineligibility period, the athlete has to undergo to four no advance notice doping testing, one of them at the moment when the sport activity is started again. When the athlete firstly retires from sport activity during the ineligibility period and then he requests to be reintegrated in sport activity, he won't be reintegrated until he informs the Agency and no advance notice doping testing is performed during a period of time equal to the ineligibility period remained when he retired.

The decision may be appealed to the Appeal Commission besides National Anti-Doping Agency in 21 days since the notification, while the decision becomes mandatory after the expiration of the mentioned period.

The decision shall be communicated to the athlete, Farul Constanta Sport Club, Romanian Weightlifting Federation, National Authority for Youth and Sport, Romanian Olympic and Sport Committee, International Weightlifting Federation and World Anti-Doping Agency.

Romanian Weightlifting Federation has the obligation to apply the provisions of the current decision and to comply with the legal provisions in force pursuant to the provisions of the article 37 and article 71 of the Law 227/2006.

Pursuant to the provisions of art.36, paragraph (4) of Law 227/2006 regarding prevention and fight against doping in sport, republished, with further amendments, the above-mentioned institutions are required to maintain confidentiality of the information communicated until the public disclosure of the case.
