Summoned on 15.05.2012, 10:00 H, at the National Anti-Doping Agency official seat in Bucharest, 37 – 39 Basarabia Blvd., sector 2, for the hearing of the athlete **WISSEH JAYTORNAH-NYANKUN**, registered to Atlasib Sibiu University Sport Club, residing in Sibiu, Oncesti Street, Sibiu County, Bl. 18, Appt. 24 at the time of the doping control and in the United States of America as of 06.04.2012, establishes:

Following the doping control conducted on the occasion of C.S.U. Atlasib Sibiu – U Mobitelco Cluj match, conducted in Sibiu, the analytical result of the sample of the athlete **WISSEH JAYTORNAH-HYANKUN**, with the code number **1986574A**, indicated the presence of the prohibited substance **acid 11-nor-9-carboxy-delta 9-tetrahydrocannabinol (carboxy THC), metabolite of delta 9-tetrahydrocannabinol**, included in the class S8 of the Prohibited List (Cannabinoids).

The *Hearing Commission* summoned on 02.05.2012 where the athlete was not present. The Atlasib Sibiu University Sport Club sent an address informing the athlete left the country on 06.04.2012 and requesting for the hearing meeting to be postponed in order to find a way to bring the athlete to the hearing or to nominate a legal representative.

By the Decision no. 7/02.05.2012 the athlete had been suspended provisionally from any national or international sport event.

The athlete was summoned again on 15.05.2012 for the hearing meeting, but he did not attend that meeting either.

The *Hearing Commission for athletes and their support personnel who violated the anti-doping rules* by reviewing the documents within the file, the analysis bulletin no. 201/25.04.2012 of Bucharest Doping Control Laboratory, as well as the national and international legal provisions:

DECIDES

The ineligibility of the athlete **WISSEH JAYTORNAH-NYANKUN**, registered to Atlasib Sibiu University Sport Club for a period of six (6) months,

pursuant to the provisions of the article 39 of Law 227/2006 regarding prevention and fight against doping in sport republished, with the further amendments.

The ineligibility period begins to run from the date of the current decision, while the provisional suspension period shall be credited against the ineligibility period.

The decision shall be communicated to the athlete, Atlasib Sibiu University Sport Club, Romanian Basketball Federation, National Authority for Youth and Sport, Romanian Olympic and Sport Committee, FIBA and World Anti-Doping Agency.

The decision may be appealed to the Appeal Commission besides National Anti-Doping Agency in 21 days since its notification.

Romanian Basketball Federation has the obligation to apply the provisions of the current decision and to comply with the legal provisions in force pursuant to the provisions of the articles 37 and 71 of the Law 227/2006.

Pursuant to the provisions of the article 36, paragraph (4) of Law 227/2006 regarding prevention and fight against doping in sport, republished, with subsequent amendments, the above-mentioned institutions are required to maintain confidentiality of the information communicated, until the public disclosure of the case.
