Summoned on 07.08.2012, 11:00 H, at the National Anti-Doping Agency official seat in Bucharest, 37 – 39 Basarabia Blvd., sector 2, for the hearing of the athlete **Laszlo Szabolcs**, registered to Dinamo Bucharest Sport Club, residing in Odorheiul Secuiesc, Harghita County, 49 Kuvar Street, establishes:

Following the doping control conducted on the occasion of the Individual Wrestling National Championship, seniors, conducted on 08.07.2012, the analytical result of the athlete's sample, with the code number **1987137A**, indicated the presence of the prohibited substance **methylhexanamine**, included in the class S6.b (Specified Stimulants).

On 26.07.2012 the above mentioned athlete was notified by the Address no. 7654/26.04.2012 that a prohibited substance was found in his sample which is an anti-doping rule violation according to the applicable law and the Hearing Commission for athletes and their support personnel who violated the anti-doping rules was going to summon on 07.08.2012.

The athlete sent a written request, registered with no. 7717/01.08.2012 at the National Anti-Doping Agency asking for a postpone of the hearing meeting after 16.08.2012 because he was out of the country until that date.

The *Hearing Commission for athletes and their support personnel who violated the anti-doping rules*, after reviewing the documents within the file, the analysis bulletin no. 533/18.07.2012 of Bucharest Doping Control Laboratory, as well as the national and international legal provisions:

DECIDES

The provisional suspension of the athlete **Laszlo Szabolcs**, registered to Dinamo Bucharest Sport Club from any national or international sport event until the final decision is made, pursuant to the provisions of art.31 of Law 227/2006 regarding prevention and fight against doping in sport, republished with subsequent amendments.

The provisional suspension period begins to run from the date of the current decision.

The *Hearing Commission for athletes and their support personnel who violated the anti-doping rules* in unanimity admits the request of the athlete Laszlo Szabolcs to have the hearing meeting postponed.

The decision shall be communicated to the athlete, Dinamo Bucharest Sport Club, Romanian Wrestling Federation, National Authority for Sport and Youth, Romanian Olympic and Sport Committee, International Wrestling Federation and World Anti-Doping Agency.

The decision may be appealed to the Appeal Commission besides National Anti-Doping Agency in 21 days since its notification.

Romanian Wrestling Federation has the obligation to apply the provisions of the current decision and to comply with the legal provisions in force pursuant to the provisions of the articles 37 and 71 of the Law 227/2006.

Pursuant to the provisions of art.36, paragraph (4) of Law 227/2006 regarding prevention and fight against doping in sport, republished, with subsequent amendments, the above-mentioned institutions are required to maintain confidentiality of the information communicated, until the public disclosure of the case.
