The World Anti-Doping Code (Code), article 4.5 states: "WADA, in consultation with other Signatories [of the Code] and governments, shall establish a monitoring program regarding substances which are not on the [2005] Prohibited List, but which WADA wishes to monitor in order to detect patterns of misuse in sport."
