DECISION
No. 17/17.10.2007

Sanctions Committee, assembled on 17.10.2007 at National Anti-Doping Agency official seat from Bucharest, 37 – 39 Basarabia Bvd., sector 2, after reviewing the file no. 3/2007, establishes the followings:

On 10.10.2007, *Hearing Commission for athletes and their support personnel* assembled for reviewing the case of the athlete **Mihaela BOTEZAN**, registered to **UNIVERSITATEA CLUJ and Army Sport Club STEAUA BUCUREȘTI**, having the address: Cluj-Napoca, Str. Ghe. Dima, No. 6, bl. D2, ap. 54, Cluj County, following the doping control conducted on 28.04.2007, and the detection in the athlete's sample of the **prohibited substance Clorthalidone**.

The Sanctions Committee, after reviewing the documents existent within the file, namely athlete's statement from 28.05.2007, where she asks for B Sample analysis, athlete's statement from 10.10.2007, where she states that she did not use intentionally the prohibited substance Clorthalidone, the bulletins of analysis of the sample 2241986A and B received from the Doping Control Laboratory from Kreischa - Germania, taking into consideration the provisions of the Decision no. 3/10.10.2007 of the *Hearing Commission for athletes and their support personnel*, pursuant to the legal provisions applicable on national and international level,

DECIDES

The ineligibility of the athlete **Mihaela BOTEZAN**, registered to **UNIVERSITATEA CLUJ and Army Sport Club STEAUA BUCUREȘTI** for a 2 (two) years period, in compliance with art. 31 of the Law no. 227/ 2006 regarding the prevention and fight against doping in sport, as she was found guilty for violating art. 2 paragraph 2 a) of the above-mentioned Law.

The ineligibility period becomes effective on the date of the present decision.

The present decision may be appealed in 10 days after notification, at the Appeal Commission besides National Anti-Doping Agency. The decision becomes compulsory after the expiration of the above-mentioned period.

The decision shall be communicated to the athlete, the club where he is registered, the relevant national sport federation, the National Sports Agency, the Romanian Olympic and Sports Committee, as well as to the World Anti-Doping Agency.

The relevant National Sport Federation has the responsibility to execute the provisions of the present decision.
