## AGENȚIA NAȚIONALĂ ANTI-DOPING

### DECISION

#### No. 30/15.12.2008

The *Sanctions Committee* met on 15.12.2008, at the National Anti-Doping Agency's official seat in Bucharest, 37-39 Basarabia Blvd, District 2, reviewing the file no. **29/2008**, establishes the following:

On 03.12.2008, the *Hearing Commission* was convened to review the case of the athlete **BALLAI Alexandru**, residing in Targu-Mures, 24, Ghiocelului Street, Mures County, registered at **CSM MURES TARGU-MURES Sport Club**, following the doping control conducted on **National Wrestling Championship – Seniors, Targu Mures** on 18.10.2008 and the detection of the prohibited substance **5 $\alpha$ -methyl-5 $\alpha$ -androstan-3 $\alpha$ -ol-17-one – metabolite of drostanolone** in the athlete's urine sample.

The *Sanctions Committee*, reviewing the documents from the file, namely the bulletin of analysis no. 614/30.10.2008 of Bucharest Doping Control Laboratory, subsequently confirmed by the bulletin of analysis no. AAF/R/927/336/2008 of Seibersdorf Doping Control Laboratory, Austria and taking into account the provisions of the Hearing Commission's Decision no. 30/03.12.2008 and the legal national and international provisions:

### DECIDES

The ineligibility of the athlete **BALLAI Alexandru** registered at **CSM MURES TARGU-MURES Sport Club**, for a period of two (2) years, according to the provisions of Article 31 of the Law no. 227/2006 regarding the prevention and fight against doping in sport, with subsequent modification and completion, the athlete being found guilty for the violation of Article 2 paragraph (2) a) of the above mentioned Law.

The ineligibility period shall start with the date of the present decision.

Pursuant to art. 30, paragraph (1) of the mentioned law, any anti-doping rules violation committed by an athlete in relation with a sport event and/or sport competition leads to the disqualification, invalidation of the individual results obtained during the relevant competition and the forfeiture of the medal, points or prizes.

The present decision may be appealed in 10 days from its notification, to the Appeal Commission besides National Anti-Doping Agency; after the expiring of the above mentioned term, the decision shall become mandatory.

The present decision shall be notified to the athlete, the sport club where he is registered, the relevant national sport federation, National Sports Agency, Romanian Olympic and Sports Committee, as well as to the World Anti-Doping Agency.

The relevant National Sport Federation shall have the responsibility to implement the provisions of the present decision.
