## AGENȚIA NAȚIONALĂ ANTI-DOPING

### DECISION

#### No. 12/23.09.2009

The *Hearing Commission for athletes and their support personnel who violated the anti-doping rules*, summoned on 23.09.2009, 09.30 H, at the National Anti-Doping Agency official seat in Bucharest, 37 – 39 Basarabia Bvd., sector 2, to review the file no. 13/2009 of the athlete **Mihai Gabriel FEROIU**, registered to **Olimpia Pro Gym Brașov Sport Club**, residing in Târgu Jiu, 126, Street 14 Octombrie, district Gorj, establishes:

Following the doping control on 15.08.2009 and 20.08.2009, sport discipline Bodybuilding, conducted out of competition in Targu Jiu, the analytical results of the athlete **Mihai Gabriel FEROIU**'s samples, with the code number **2450027A** respectively **2435580A**, indicated the presence of the metenolone CP respectively metenolone, 1-metilen-5 $\alpha$ -androstan-3 $\alpha$ -ol-17-one – metabolite of metenolone and 1 $\alpha$ -metil-5 $\alpha$ -androstan-3 $\alpha$ -ol-17-one – metabolite of mesterolone.

The substances detected in athlete's samples are included in the class S1.1.a. of the Prohibited List.

The *Hearing Commission for athletes and their support personnel who violated the anti-doping rules* takes into account the fact that the athlete commits now the second violation of the art. 2 paragraph (2) of the Law no. 227/2006 regarding the prevention and fight against doping in sport, republished and he had been previously sanctioned with two years of ineligibility by the decision of the *Sanctions Committee* no. 15/17.10.2007, following the violation of the art. 2 alin. (2) letter a) of the above-mentioned law.

The *Hearing Commission for athletes and their support personnel who violated the anti-doping rules* reviewed the documents within the file, namely the analysis bulletins no. nr. 245/02.09.2009 and respectively nr. 348/03.09.2009 of Bucharest Doping Control Laboratory and took into account the fact that the athlete commits now the second anti-

doping rules violation as well as the fact that the athlete did not show up to the hearing although he had been legally notified about it and pursuant to the legal provisions on national and international level:

## **DECIDES**

The LIFETIME ineligibility of the athlete **Mihai Gabriel FEROIU**, registered to **Olimpia Pro Gym Braşov Sport Club**, pursuant to the provisions of the art. 39 and art. 47 paragraph (1) letter b) of the Law 227/2006 regarding the prevention and fight against doping in sport republished as he is guilty of violating the provisions of the art. 2 paragraph (2) letter a) of the mentioned law.

The ineligibility period starts at the date of the current decision.

The decision may be appealed in 21 days since the notification to the Appeal Commission besides National Anti-Doping Agency, the decision becoming mandatory once the above-mentioned term expires.

The decision shall be communicated to the athlete, the club where he is registered, to the relevant national sport federation, the Ministry of Youth and Sport, Romanian Olympic and Sport Committee, relevant international federation and the World Anti-Doping Agency.

Romanian Bodybuilding and Fitness Federation has the obligation to apply the provisions of the current decision and to comply with the legal provisions in force in compliance with the provisions of the article 65, paragraph (1) of the Law 227/2006 republished.
