DECISION No. 9/14.01.2010

The *Hearing Commission for athletes and their support personnel who violated the anti-doping rules*, summoned on 14.01.2010, 10:00 H, at the National Anti-Doping Agency official seat in Bucharest, 37 – 39 Basarabia Bvd., sector 2, to review the file no. 40/2009 of the athlete **Ioan MOLDOVAN**, registered to **Târgu Mureș University Sport Club**, residing in Livezeni, 263, Principala Strret, Mureș County establishes:

Following the doping control on 05.09.2009, on sport discipline Bodybuilding, on the occasion of National Championship of Bodybuilding, organized in **Brasov**, the analytical result of the sample of the athlete **Ioan MOLDOVAN** with the code number **2450101A**, indicated the presence of Testosterone/Epitestosterone ratio > 4 (T/E $>$ 4). In order to determine the origin of the prohibited substance by the analytical method IRMS – Isotope Ratio Mass Spectrometry – athlete's sample was sent to the Doping Control Laboratory of Cologne, Germany, which indicated based on the analyses performed the administration of **testosterone** or **pro-hormones of testosterone**.

The substance detected in athlete's sample is included in the class S1.1.b. of the Prohibited List.

The *Hearing Commission for athletes and their support personnel who violated the anti-doping rules* takes note of the fact that the athlete commits the second violation of the anti-doping rules, as he was suspended from sport activity in 2002.

The *Hearing Commission for athletes and their support personnel who violated the anti-doping rules* reviewed the documents within the file, namely the analysis bulletin no. 406/25.09.2009 of Bucharest Doping Control Laboratory and the analysis bulletin no. S2009006639 of Cologne Doping Control Laboratory, Germany and athlete's statement as of 14.01.2010, where he states that he does not request B sample analysis, pursuant to the legal provisions on national and international level:

DECIDES

The lifetime ineligibility of the athlete **Ioan MOLDOVAN**, registered to **Târgu Mureș University Sport Club** pursuant to the provisions of the art. 39 of the Law 227/2006 regarding the prevention and fight against doping in sport republished as he is guilty of violating the provisions of the art. 2 paragraph (2) letter a) of the mentioned law.

The ineligibility period starts at the date of the current decision.

The decision may be appealed in 21 days since the notification to the Appeal Commission besides National Anti-Doping Agency, the decision becoming mandatory once the above-mentioned term expires.

The decision shall be communicated to the athlete, the club where he is registered, to the Romanian Bodybuilding and Fitness Federation, the Ministry of Education, Research, Youth and Sport, Romanian Olympic and Sport Committee, relevant International Federation and the World Anti-Doping Agency.

Romanian Bodybuilding and Fitness Federation has the obligation to apply the provisions of the current decision and to comply with the legal provisions in force in compliance with the provisions of the article 65, paragraph (1) of the Law 227/2006 republished.
