DECISION
No. 5/19.02.2008

Sanctions Committee, assembled on 19.02.2008 at National Anti-Doping Agency official seat from Bucharest, 37 – 39 Basarabia Blvd., sector 2, after reviewing the file no. 1/ 2008, establishes the followings:

On 11.02.2008, respectively 19.02.2008, the *Hearing Commission for athletes and their support personnel* assembled for reviewing the case of the athlete **DUMBRAVEAN CORINA** – sport discipline: athletics, registered to Olimpic Craiova Sport Club, having the address: Craiova, 22, Stirbei Voda Street, Dolj County, following the out of competition doping control conducted on 16.11.2007, and the detection in the athlete's sample of the prohibited substance **NESP (Novel Erythropoiesis Stimulating Protein)**.

The *Hearing Commission for athletes and their support personnel* took notice about the fact that on 11.11.2007, the athlete suffered from an acute renal deficiency and oligoanuria, involving unconsciousness, for which the athlete was hospitalized urgently. In order to have the health conditions treated, the athlete was administrated also some medicines that contained substances included on the Prohibited List.

The *Hearing Commission for athletes and their support personnel* also decided that the athlete DUMBRAVEANU Corina proved the lack of guilt or significant negligence, establishing that she did not know and she did not suspected (and she could not have known or could not have suspected, no matter how attentive she would have been) that she was administrated also prohibited substances.

The *Sanctions Committee*, after reviewing the documents existent within the file, namely athlete's statement from 11.02.2008, the bulletin of analysis for the sample no. 3001734A/B issued by the Doping Control Laboratory from Switzerland, the medical file elaborated by the ER personnel within County Clinical Emergency Hospital Craiova from 11.11.2007, the paper written when she left the hospital, on 12.11.2007, the statement of the specialist doctor – emergency medicine Anca POPA, as well as the provisions of the Decision no. 5/19.02.2008 of the *Hearing Commission for athletes and their support personnel*, pursuant to the legal provisions applicable on national and international level,

DECIDES

Not to apply the sanction of ineligibility to the athlete **DUMBRAVEAN Corina**, registered to **Olimpic Craiova Sport Club**, in compliance with art. 39 (paragraph 2) corroborated with art. 39 (paragraph 4) of the Law no. 227/ 2006 regarding the prevention and fight against doping in sport, as she proved no guilt or significant negligence.

The present decision may be appealed in 10 days after notification, at the Appeal Commission besides National Anti-Doping Agency. The decision becomes compulsory after the expiration of the above-mentioned period.

The decision shall be communicated to the athlete, the club where he is registered, the relevant national sport federation, the National Sports Agency, the Romanian Olympic and Sports Committee, as well as to the World Anti-Doping Agency.

The relevant National Sport Federation has the responsibility to execute the provisions of the present decision.
