ADMINISTRATION

The Finnish Antidoping Agency (FINADA) comprises five members: the Finnish Sports Federation, the Finnish Olympic Committee, the Finnish Paralympic Committee, the Finnish Society of Sports Medicine and the Finnish Government, represented by the Ministry of Education.

GENERAL MEETINGS

FINADA's statutory spring meeting was held on 25 April 2007 at the Finnish Sports Federation's headquarters in Helsinki.

The spring meeting dealt with statutory matters, including adopting the financial statements and the annual report.

FINADA members represented at the autumn meeting were the Finnish Olympic Committee, the Finnish Paralympic Committee and the Finnish Government (the Ministry of Education).

FINADA's statutory autumn meeting was held on 20 November 2007 at the Finnish Sports Federation's headquarters in Helsinki.

The autumn meeting dealt with statutory matters, including ratifying the action plan and budget for 2008. The autumn meeting elected the new FINADA board for 2008-2009. Kari-Pekka Titinen, Professor of Labour Law, was elected as the Chairman of the Board on the mandate of the Finnish Olympic Committee. (Members of the Board are listed in Appendix 1.)

FINADA members represented at the autumn meeting were the Finnish Sports Federation, the Finnish Olympic Committee, the Finnish Paralympic Committee and the Finnish Government (the Ministry of Education).



BOARD

FINADA's Board convened nine times during the year under review. In addition, the Board held one informal meeting to discuss topical issues. The members of the Board are listed in Appendix 1. The Chairman of the Board Olli Puntila resigned at the end of May 2007 and it was decided that Deputy Chair Mirja Virtala would act as the Chair until the end of the year when the autumn meeting decided on the new Chair for 2008-2009.

The Board and FINADA's office staff held a strategy meeting in Siikaranta, Espoo, on 11–12 June 2007.

SUPERVISORY GROUP

The Supervisory Group convened 10 times in 2007. (The members of the Supervisory Group are listed in Appendix 1.)

OFFICE

FINADA's office employed eight full-time employees and one part-time employee in 2007. Pirjo Krouvila, FINADA's Director of International Affairs and Development was appointed as new Secretary General after Juha Viertola was appointed Director of Sport Policy of the Finnish Sports Federation. Long-time Doping Control Manager Teuvo Valtanen left his post in the FINADA. Re-organisation of the office activities took place in late 2007. (Office staff are listed in Appendix 1.)



DOPING CONTROL AND TESTING

DOPING CONTROL

In 2007, FINADA carried out 1,911 doping tests in Finland and abroad. A total of 1,774 (in 2006: 1,381) tests belonged to FINADA's national testing programme.

FINADA carried out 137 international in- and out-of-competition tests both in Finland and abroad at the request of international sports federations and WADA (152 in 2006), 87 of which were in-competition and 50 out-of-competition.

The number of in-competition tests in the national testing programme was 892 (755) and the number of out-of-competition tests 877 (626). Tests were carried out in 72 disciplines. The most tested disciplines in FINADA's testing programme were athletics with 221 (167), skiing with 153 (116), ice hockey with 175 (199). There were five doping violations in 2007: motor

sports, weightlifting (2), powerlifting and athletics. (Doping test statistics, Appendix 2.)

The price per individual test continued to grow due to increased laboratory costs and targeted out-of-competition testing. The laboratory costs were inflated by a higher number of compounds to be analysed and the increased monitoring and analysis of additional samples.

As in previous years, the testing of Finnish international level athletes in various disciplines was targeted at out-of-competition testing. Tests were carried out both in Finland and abroad.

In 2007, FINADA did not carry out blood tests on its own initiative, but a blood-testing project was launched together with United Laboratories Ltd. The project aims at making blood testing part of FINADA's national testing programme. FINADA carried out blood tests at the request of interna-

tional sports federations and WADA.

The administration of FINADA's testing pool and the athletes' whereabouts information system were further improved. By the end of the year, the pool included approximately 300 athletes from various disciplines. Monitoring athletes' whereabouts information using the testing pool system enables FINADA to carry out targeted out-of-competition testing and is a tool for administering and implementing doping control. Due to limited human resources, the number of athletes in the testing pool decreased.

All in all, 27 doping control officers trained and authorised by FINADA operated all over Finland. The annual training seminar for doping control officers and doping control assistants was organised in Tampere on 26–28 January 2007. The training brought the knowledge of both doping control officers and doping control assistants



up to date. The training focused on the feedback from testing audits and reformed guidelines.

THERAPEUTIC USE EXEMPTIONS

The beginning of 2004 saw the adoption of therapeutic use exemption in accordance with the International Standard confirmed by WADA. The aim of the International Standard is to create a uniform global practice for various organisations in granting therapeutic use exemptions. A new four-member Therapeutic Use Exemption Committee (TUEC) started its operations, the first order of business of which was to process the therapeutic use exemptions in the application process. (The members of the Therapeutic Use Exemption Committee are listed in Appendix 1.)

Approximately 1,000 therapeutic use exemptions were processed in 2007. There were approximately 650 new exemptions and, due to their temporary validity, the rest were renewals.

Approximately 10% were actual therapeutic use exemption applications, and the remainder were abbreviated therapeutic use exemptions. Despite the national discipline-specific determination of level, the overall figure remained at previous year's levels.

QUALITY MANAGEMENT

A quality management system supports the continuous development of FINADA administration and testing activities. The FINADA quality system fulfils the requirements of ISO 9001:2000 and WADA's International Testing Standard. The system has been certified by Det Norske Veritas (DNV). In 2007, DNV re-evaluated the conformity of the testing quality management system and renewed FINADA's certification.

During the year in review, FINADA implemented seven internal audits of doping control officers.

The results of the audits were utilised in the maintenance of the system and procedures, as well as in the training of doping control officers. There was one internal audit of administration.

The reform process of WADA's International Testing Standard was moved to 2008, so the planned changes in guidelines and procedures, as well as the required training, will be implemented when the new standard is published. FINADA commented on the proposed changes to the WADA International Testing Standard during the consultation. Moreover, FINADA informed national sports federations on the proposed changes to the testing standard and on their effects on the sports federations and athletes in the testing pool.



EDUCATION

FINADA was in active co-operation with bodies organising education. In 2007, FINADA organised or participated in approximately 87 education and training events. Training events were mainly organised in collaboration with sports federations, but other sports organisations and bodies involved in sports also collaborated in organising training and education. A list of the training events is attached. (Training events, Appendix 3.)

The main target groups were young and elite athletes; however, antidoping education was increas-

ingly provided in connection with instructor and coach education. Furthermore, FINADA played an active role in developing coach and instructor education. FINADA defined the aims and methods for antidoping work in the levels I-III coach and instructor education.

FINADA participated in the drawing up of sports federations' antidoping programmes. The co-operation with the sports federations also included various competitions by, for example, participating in sports federations' information stands by providing information and guidance on anti-

doping activities for various parties involved in sports.

Together with the Communications Department, FINADA's Education Department produced antidoping materials (see Communications.)



COMMUNICATIONS

FINADA'S MATERIALS

Prohibited Substances and Prohibited Methods in Sports 2007 were published on FINADA's website on 1 January 2007 and the printed version came out in January. The publication was distributed to sports federations, sports institutes, pharmacies and other FINADA interest groups. Additions and updates to Prohibited Substances and Prohibited Methods in Sports were published on the FINADA website during the year. The updates were also distributed electronically.

FINADA updated its printed materials in early 2007. The most important guidelines, the anti-

doping brochures for young athletes and coaches and the appendix on the therapeutic use exemptions were updated and published on the FINADA website.

During the year under review, four newsletters for sports federations and doping control officers were published. A new bi-annual newsletter for doping control officers entitled "TestiApu" was launched.

Materials and newsletters were produced in collaboration between education and testing departments.

EVENTS

Information seminars for sports federations were organised in spring and autumn. The events attracted many federations that have not previously attended FINADA's seminars.

A press conference was organised in conjunction with the Finnish Ski Association. The press conference was on the construction of the anti-doping quality management system for the Finnish Ski Association. In addition, FINADA organised the "Fair Play – suora puhetta dopingista" ('Fair Play – straight talk about doping') seminar together with the Sportswriters' Association in Finland.



INTERNATIONAL ACTIVITIES

THE WORLD ANTI-DOPING AGENCY (WADA)

WADA's most important project in 2007 was the reform of its Code. The Code went through three consultation rounds in international sports federations, governments and national antidoping agencies. The Code was adopted in the WADA's Foundation Board in the World Conference in Madrid on 15-17 November 2007. The new world antidoping code will enter into force on 1 Jan 2009.

During the year, WADA also commenced the revision of the international standards for testing, laboratory and therapeutic use exemptions. The International Standard for Laboratories took effect on 1 January 2008. The International Standards for Testing and for Therapeutic Use Exemptions were approved in May 2008 and will come into force on 1 January 2009.

One of WADA's most significant projects was the development of regional antidoping agencies and its related education. In the projects, several small countries establish a joint antidoping

agency, which will then be responsible for antidoping activities in all member countries. There are currently 11 such units encompassing over 100 countries.

In 2007, Finland was represented in WADA's Ethics & Education Committee, which acts as an expert body for the WADA Executive Committee, creates policies and develops the antidoping education implemented by WADA. The education seminars are largely connected to the activities of regional antidoping agencies.

A FINADA representative acted as an independent observer in the All African Games on 9-19 July 2007. The general observation of the independent observer group was that there remains a lot to be done in antidoping work on the African continent.

FINADA representatives also participated in the doping control officer training organised jointly by WADA and Anti-Doping Norway in Tromsø, Norway on 23-24 May 2007.

EUROPEAN COUNCIL

During the year, The Monitoring Group for the European Council Anti-Doping Convention focused on the revision of WADA Code. The Legislative Committee chaired by Finland, jointly commented on the Code and prepared the stand of the European Council on the issues pertaining to data privacy in antidoping activities.

THE UNITED NATIONS EDUCATIONAL, SCIENTIFIC AND CULTURAL ORGANIZATION (UNESCO)

The UNESCO International Convention against Doping in Sport entered into force on 1 February 2007, and the first conference of state parties was held in Paris on 5-7 February 2007. The Conference of Parties convenes biennially. It is important to WADA that nations are committed to supporting and developing its activities by signing the Convention at a governmental level. By the end of 2007, approximately 60 countries had ratified the Convention.



ASSOCIATION OF NATIONAL ANTI-DOPING ORGANISATIONS (ANADO)

The Association of National Anti-Doping Organisations (ANADO) is growing rapidly. At the time of its establishment there were 16 members. By the end of 2007, there were over 50 members. ANADO was very active in 2007. Finland currently sits on the Board of ANADO.

Future tasks include membership services (the Internet, press releases, seminars and mentoring), improving co-operation particularly with WADA but also with other players in the field of sports, as well as developing the doping control and educational services.

Together with WADA, ANADO organised a seminar for national antidoping agencies and international sports federations. Doping control agreements were concluded with WADA and several international sports federations.

ANADO's education activities focused on national antidoping agencies' central development issues in testing, the construction of ICT systems,

the creation of educational programmes and in the revision of the World Anti-Doping Code and standards.

INTERNATIONAL ANTI-DOPING ARRANGEMENT (IADA)

The International Anti-Doping Arrangement (IADA) is a governmental collaboration body of the world's leading high-quality antidoping countries and their national antidoping agencies. Denmark chaired the IADA and ran the Secretariat in 2007-2008. Denmark has focused on bringing forth issues pertaining both to the WADA Code and the challenges in preventing the use of doping in gyms and outside of organised sports. Finland will chair the IADA in 2009-2010.

NORDIC CO-OPERATION

Nordic co-operation is important for the development of FINADA's activities and joint efforts at international lobbying. Annual meetings address organisational solutions, funding, testing, education and research. The 2007 meeting was held in Stockholm on 31 May-1 June 2007.

THE EUROPEAN UNION

The European Union has drawn up a White Paper on Sport, in which antidoping co-operation is also discussed. FINADA has issued comments on the white paper to the Ministry of Education.

In collaboration with the European Union, Germany has been preparing an initiative to create a European network of antidoping agencies. FINADA expressed its opinion in the meeting of the preparatory committee. FINADA does not support the creation of a new organisation but rather hopes that co-operation will function flexibly in the guise of an electronic network, the members of which will be invited to assemble when needed.

OTHER CO-OPERATION

On 24-25 April 2007, FINADA organised an education event on the quality management, doping control and educational activities for the Latvian Antidoping department in Finland. The Latvians also got to visit the United Laboratories Ltd.

RESEARCH AND REPORTS

FINADA aims to promote antidoping research by organising negotiations, informing about different funding options and, when needed, supporting the launch of various projects. Co-ordination meetings for antidoping research are organised every two years.

In 2007, the most significant research was undertaken by United Laboratories Ltd. with WADA funding. The scope of research was the development of analytical methods. WADA allocates USD 6,000,000 for international antidoping

research in biomedicine and USD 200,000 for research in behavioural and social sciences.



FINANCES

IMPORTANT EVENTS DURING THE FINANCIAL YEAR AND AFTER

The finances of FINADA are based on operational assistance and aid granted for separate projects by the Ministry of Education. No initiation or membership fees apply to members. The Ministry of Education operational assistance for 2007 was €1,400,000. Additional aid of €30,000 was granted mainly for developing blood testing methods. At the end of the year, the Ministry of Education granted FINADA €60,000 for the de-

velopment of an electronic doping testing management system.

FINADA's accounts for 2007 show a deficit of €79,856.85. FINADA received approximately €35,000 in refunds from employees' pension contributions. In bookkeeping, the tests carried out in international competitions showed a surplus of €14,400. This is explained by more accurate invoicing that corresponds to the actual costs. In 2007, doping control in international competitions was carried out as part of the nor-

mal duties of FINADA staff; the costs were thus included in the administrative personnel costs.

FINADA applied for a general appropriation of €1,500,000 for its 2008 operations from the Ministry of Education. The appropriation would have enabled keeping the testing activities at the level of previous years.

SUMMARY

Between 1 Jan 2007 and 31 Dec 2007, 1,911 doping tests were conducted in Finland. Tests conducted by FINADA totalled 1,769, while national sports federations requested five record tests. Another 137 tests were conducted by FINADA in international competitions and out of competition.
