The 2013 World Conference on Doping in Sport is being organised by the World Anti-Doping Agency, with the generous support of Sport and Recreation South Africa and the City of Johannesburg. It will take place November 13-15, 2013 (with registration beginning the afternoon of November 12th).

This fourth World Conference of its kind will be another milestone in the fight against doping. It will approve the 2015 World Anti-Doping Code and International Standards. All NADOs and RADO should try to attend this major event.

Opportunities for NADOs: Regional Games

Regional Games offer NADOS and RADOs an excellent chance to provide service and build anti-doping capacity. They are a tremendous opportunity to better educate athletes and their support personnel about the risks of doping and the importance of clean sport.

The Bahamas Anti-Doping Commission and the Caribbean RADO recently provided the anti-doping programme for the 2013 CARIFTA Games: http://www.carifta2013.info/

The CARIFTA Games is an annual athletics competition founded by the Caribbean Free Trade Association (CARIFTA). The Games was first held in 1972 and consists of track and field events including sprint races, hurdles, middle distance track events, jumping and throwing events, and relays. Interestingly, these Games have two age categories: under-17 and under-20. So they are a particularly useful occasion to connect with developing athletes.

WADA Warning about GW501516

As many of you know, on March 21, 2013, WADA issued a warning about the development drug GW501516. It was withdrawn from research by the pharmaceutical company and terminated when serious toxicities were discovered in pre-clinical studies. Clinical approval has not, and will not be given for this substance. See: http://playtrue.wada-ama.org/news/wada-issues-alert-on-gw501516/

However, GW501516 has been available for some months on the black market, through the Internet and elsewhere. Anti-Doping Organisations have already seen its use by athletes, as there are a number of positive cases. Here is a report of one in the sport of cycling:

Of course that information always has to be assessed, and action based on frivolous or malicious information avoided. But this is a way that all NADOs and RADOs should consider to generate anti-doping intelligence.
