## Sponsor Concern about Doping in the Australian National Rugby League (NRL)

One development in the aftermath of the recent Australian Crime Commission Report, and the ongoing ASADA investigations, is the concern of NRL club sponsors. This is parallel to the situation in men's road cycling in Europe, and the departure of Rabobank as a team sponsor in late 2012. This indicates that in commercialised, professional sport, the leagues and teams have a clear financial interest in clean sport and should increase their own anti-doping efforts.

And in a breaking development, the NRL Club in question has taken dramatic action based on an internal review conducted by the former ASADA Deputy-Chair (and Judge and CAS Arbitrator) Tricia Kavanagh. ### Interview with Betsy Andreu about Lance Armstrong

This link takes you to an extensive interview with one of the original Armstrong "whistleblowers," the wife of former teammate Frankie Andreu. Questioned by Dick Gordon, Andreu has lots of interesting observations on the dynamics of cycling teams, on cycling before USADA and WADA were operational (Frankie Andreu was dismissed from Armstrong's team after the 2000 Tour de France for refusing to continue to dope), on the role of journalists in exploring doping in cycling (or not), on the potential of dopers to come clean and help anti-doping efforts, and on the personal cost of being an anti-doping whistleblower. Well worth listening to the entire 30 minutes.

#### Travis Tygart in Sports Illustrated Top 50 Most Powerful People in Sports

Speaking of Sports Illustrated, Travis ranks 37<sup>th</sup> (ahead of President Obama, who rated 44<sup>th</sup>) in that American magazine's annual rating of the most powerful people in sport. And just behind Sheikh Mansour bin Zayed Al Nahyan, UAE Deputy Prime Minister and Manchester City owner. Clearly this is a U.S.-oriented ranking: the Commissioners of the NFL and NBA were 1<sup>st</sup> and 2<sup>nd</sup>, while Jacques Rogge merited 8<sup>th</sup> and Seth Blatter 16<sup>th</sup>. Nevertheless, as the description puts it:

"World Anti-Doping Agency director David Howman is known for his straight talk about drugs in sports, but in 2012 it was Tygart, 41, who became the face of the fight against doping. His agency's investigation of Lance Armstrong -- amid character attacks and death threats against Tygart, and despite efforts to remove USADA's funding -- proved that no athlete is above the rules."
