#### Advice to Athletes with a Possible ADRV

Athletes who receive an AAF usually need help understanding the process that will determine if they have committed an ADRV and, if so, the consequences. Based on an earlier CCES model, the IPC has prepared an informal guide to results management and hearings for athletes with an AAF: "I Tested Positive?" A copy is attached. #### **RUSADA Services in CIS Countries**

The Commonwealth of Independent States (CIS) is a regional organization of countries which are former Soviet Republics. Collecting samples in these countries, such as in Belarus, Ukraine, Armenia and Georgia, can be difficult. One solution is to use the services of RUSADA.

RUSADA has agreements permitting it to collect samples in such CIS countries, as well and the experience and language capabilities to do so. RUSADA DCOs have vise-free access to these countries. Its doping control is certified in accordance with ISO 9001.

RUSADA has also conducted a seminar on education programs for colleagues from Belarus sharing RUSADA education vision, strategy, tools and evaluation. It has assisted the Armenian NADO to undergo ISO certification. In addition, RUSADA will conduct a training session for Ukrainian DCOs in March.

# Debate over the Proposed Australian Legislation Giving ASADA Powers to Compel Information

Below is a link to the proposed legislation (or "Bill"). The Explanatory Memorandum below the links to the text of the Bill gives a detailed review of the purpose of the proposed legislation, and each clause. It includes a "Statement of Compatibility with Human Rights." From the Explanatory Memorandum, a summary of the purpose of the proposed legislation:

"ASADA has the authority to undertake investigations into possible doping offences. However, ASADA's powers have been limited. In his review of Australian cycling, the Hon James Wood AO QC identified that ASADA's inability to compel someone to attend an interview or produce information / documents potentially limits the capacity of ASADA to investigate allegations or suspicions of doping. This was a deficiency that needed to be addressed.

"The main purpose of the Bill is to give the CEO a power, subject to appropriate protections, to compel persons to attend an interview with an investigator nominated by the CEO and to produce information and documents or things relevant to the administration of the NAD scheme. Importantly, under this Bill, the CEO has been not given any powers relating to search and seizure; or surveillance.

"The Bill will also amend the Australian Postal Corporation Act 1989 to allow Australia Post to share information with ASADA. ASADA has benefitted from information sharing arrangements with other Government agencies such as the Australian Customs and Border Protection Service.



Establishing an information sharing arrangement with Australia Post will further enhance ASADA's investigative capacity."
