**iNADO Legal Note #3: Whereabouts Cases**

A colleague recently contacted me asking whether I knew of CAS or other decisions involving whereabouts requirements. There are not many of them. So I compiled a preliminary list:

From the Anti-Doping Knowledge Center ([www.doping.nl](http://www.doping.nl)) I get two relevant decisions searching for “whereabouts” in the collection of legal sources (which provides 16 “hits”):

CAS 2011\_A\_2671 UCI vs Alex Rasmussen & The National Olympic Committee and Sports Confederation of Denmark [sic]

CAS 2011\_A\_2499 Albert Subirats vs FINA (the FINA decision appealed from is: [http://www.fina.org/H2O/docs/antidoping/reports/Subirats\\_decision.pdf](http://www.fina.org/H2O/docs/antidoping/reports/Subirats_decision.pdf))
