The parallels between cheating clean sport and cheating auto emissions standards are striking.

The author's comments on VW's staff reminds us that, fundamentally, cheating is a question of values (also reminding us that doping invariably involves more than the doped athlete (usually members of the athlete's entourage)):

"It seems safe to assume that the cheating was not the act of one rogue coder — just as rogue traders in banks are rarely entirely to blame for their misconduct, despite the protestations of the banks. Many VW engineers and executives must have known something was going on. No doubt, most of these men and women considered themselves upstanding members of society. They attended church, donated to charities, paid taxes, helped neighbours, followed rules, volunteered, parented, cared."

The author gives these "excuses" VW engineers and executives might have said to themselves, excuses we have heard in the anti-doping world over the years:

- "Everybody is doing it" (Hyundai and Kia were fined \$100 million in 2014 for emissions testfixing)
- "If we don't do it, somebody else will"
- "No one's getting hurt" (a complete fallacy)
- "I was only doing my job" (I was just doing what more senior people told me to do)
- "The end justifies the means" (in VW's case, beating Toyota to become the largest automobile company in the world)
- "It's not really cheating, anyway"

The author concludes: "...if you hear any such remarks in your own workplace, then alarm bells should be ringing. And if your hear yourself saying them, perhaps you deserve what you get. VW appears to have demonstrated very effectively that unethical business can lose you respect, reputation – and a great deal of money." Sound familiar?

WADA Independent Commission – Second Report

The second part of the WADA Independent Commission, addressing allegations of systematic doping and "corruption and bribery" in international athletics, will be released on January 14th at a media conference in Munich, Germany

NADOs and RADOs should each have communications plan ready to deal with the media and public interest in the second report. General points to make include:

- The importance of independence for anti-doping organisations and their programmes
- The key role of investigations in protecting clean sport and athletes
- The need to encourage and protect anti-doping and corruption whistleblowers
- WADA's fundamental function as a regulator and overseer of anti-doping organisations

You should also be prepared to follow-up the findings or recommendations in the second report replating to the sport of Athletics in their own countries.
