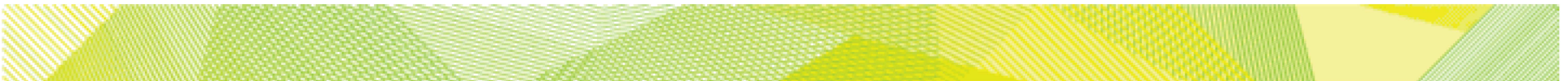

Organizational steps

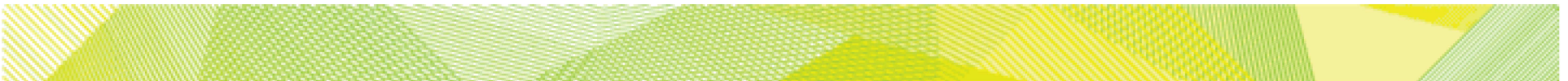
1. Governmental round table committee → recommendation on rearranging ethical issues in sport
2. Lauri Tarasti feasibility study on the rearrangement of sports ethical issues in Finland
3. Ministry of Education and Culture nominated a Committee on Antidoping Co-operation with Authorities
4. Initiative on a new organization on ethics in sport → government and ADO/Ethical issue
5. FINADA MOU with Finnish Customs





Finnish Advisory Board for Integrity in Sport → Government

- › Monitors and develops joint activities with sports, betting sector and public authorities
- › Keeps track on international co-operation
- › Makes recommendations and motions
- › *A sub-committee → functions as the National Platform in Prevention of Manipulations of Sports Competitions*

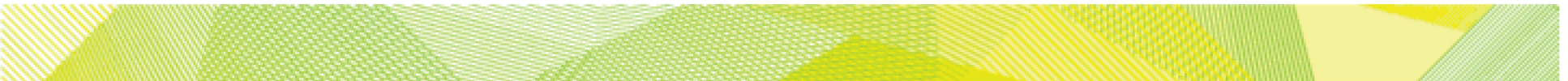

- › Creating an overall national action plan

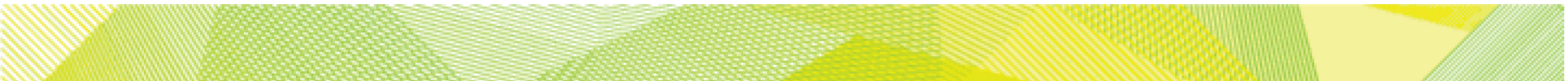

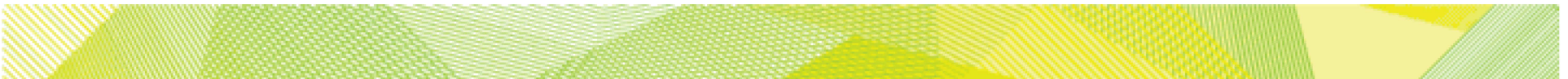

FINADA New Organization 2016

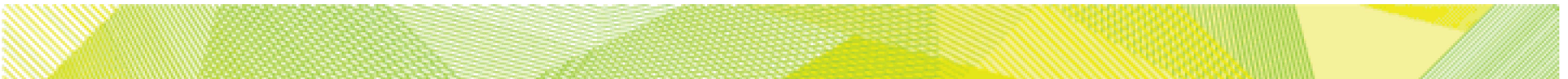
- › Finnish Center for Integrity in Sports FINCIS→ implementation of the governmental policy
- › Finnish Antidoping Agency FINADA can be used as auxiliary business name
- › FINADA is used in doping controls and material connected to doping control
- › New resources has been allocated to FINCIS





Finnish Center for Integrity in Sports FINCIS

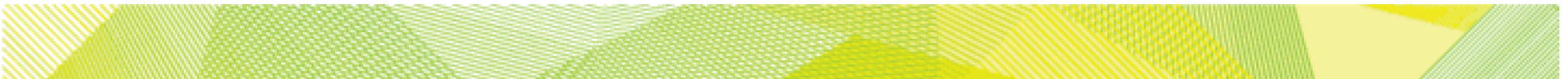
- Following the international agreements (UNESCO, Council of Europe)

Finnish Center for Integrity in Sports FINCIS

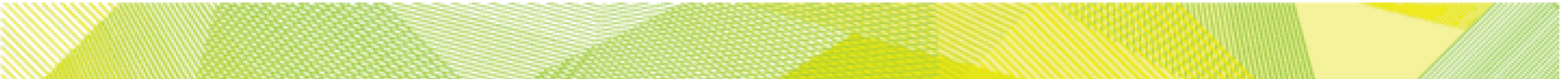
- › ***Antidoping***
 - › Updating and implementation of the Finnish Antidoping Code
 - › Responsibility of doping control in Finland
 - › Investigation of Antidoping rule violations in sports
- › ***Manipulation of sports competitions***
 - › Prevention activities
 - › Clearing house for issues of manipulation of sports competitions
- › Investigations of violations in sports





Finnish Center for Integrity in Sports FINCIS

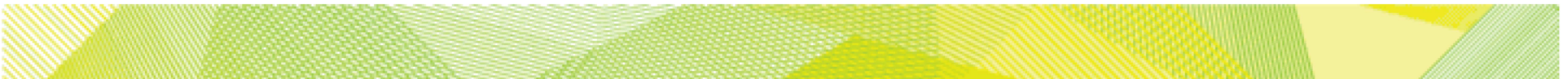
- › ***Spectator violence***
- › Preventive activities
- › Records of entrance prohibition/spectator violence/open
- › Investigation of violations in sport





Finnish Center for Integrity in Sports FINCIS

- › Legal challenges
- › FINCIS a private association
- › Revising doping act in the Finnish Criminal Code
- › Creating legislation on sports crimes in Finland
- › Currently match fixing can be penalized only via legislation on professional workers
