### **Update on iNADO CEO Recruitment (by Doug MacQuarrie, Chair iNADO)**

iNADO has been fortunate and benefitted greatly from the leadership of Joseph de Pencier as its inaugural CEO. Regrettably, all good things must come to an end and Joseph has indicated it is time for him to move on. When Joseph steps down at the end of the calendar year, we will miss him greatly. Since announcing that iNADO would undertake a search to replace Joseph, we have been focussed on an orderly process to ensure that the incoming CEO helps us to maintain strong member service and solid international performance.

A job profile, call for applications and recruitment plan was announced at the iNADO AGM in March, circulated among the iNADO Membership and posted on the iNADO website. Applicants were invited to apply in confidence to iNADO Chair, Doug MacQuarrie. Several reminder messages were circulated to the membership.

The Competition closed on May 29, 2017. All applicants to the process received an acknowledgement message and an indication of the proposed timeline for the Selection Panel to screen applicants, form a short list and interview prospective candidates by the end of July, 2017. A five person Selection Panel, chaired by Herman Ram and independent from all applicants, has been formed and includes 3 iNADO Board members and 2 non-Board members.
