WORD FROM THE CHIEF EXECUTIVE OFFICER



It is one year now since the Anti-Doping Agency of Kenya (ADAK) became fully operational. It has been a year of many challenges with many lessons learnt even as we realized a few operational mistakes. The small team at ADAK took those challenges and mistakes positively and converted them into experiences from which valuable lessons were drawn.

During those formative stages, ADAK benefited immensely from the enormous goodwill from Kenya's political leadership, as well as, the Kenyan public at large. Sports, particularly athletics (field and track), remains a key activity in the country. It rallies communities together, breaks ethnic boundaries and brings out a great sense of patriotism in all. It is also one of the greatest, single contributors of marketing of the 'Brand Kenya' for tourism and investment. Kenyans of all walks of life are willing to protect and ensure its integrity.

The new Agency also benefitted a lot from guidance and support from international partnerships. The World Anti-Doping Agency (WADA), Anti-Doping Norway (ADNo), United Kingdom Anti-Doping (UKAD), Chinese Anti-Doping (CHINADA), South African Institute for Drug-free Sports (SAIDS) and the Regional Anti-doping Organization (RADO, Africa Zone V) have been on hand all along the way with support on best practices, capacity building and other related support.

Internally, we continue to work with other government agencies and bodies whose operations impact directly and indirectly on the operational mandate of ADAK. These include, but are not limited to, the Criminal Investigations Department (CID) of the Kenya Police Service; in particular the Anti-Narcotics section, The Department of Immigration, The Kenya Medical Practitioners and Dentists Board (KMPDB), Kenya Pharmacy and Poisons Board (KPPB) and the National Registration Bureau among others. Operational documents and protocol have been, and continue to be, developed to protect information and materials shared with these bodies.

It has clearly been a busy year whose highlights included Kenya's preparation for the World Under 18 Championships and the carrying out of mandatory tests for Team Kenya selected for the International Association of Athletics Federations (IAAF) World Championships to be held in London in August. In all these ADAK gave a good account of itself, even as it continues to enhance its capacity through competitive recruitment of Staff and training of the same to achieve the required level of competence.

BACKGROUND

Kenya is a signatory to the 2005 UNESCO Convention against Doping in Sports. Article 5 of the Convention states that, "In abiding by the obligations contained in this convention, each State Party undertakes to adopt appropriate measures. Such measures may include legislation, regulation, policies or administrative practices".

In addition to the above, Article 22 of the World Anti-Doping Code 2015 further specifies that each Government will put in place measures to enhance cooperation and sharing of information and data with Anti-Doping Organisations as provided in the Code.

It is against this background that the Government of Kenya established the Anti-Doping Agency of Kenya (ADAK) vide Anti-Doping Act No.5 of 2016 as a State Corporation.

In 2011, the Ministry of Sports together with the National Olympic Committee of Kenya (NOCK) formed what was called the Kenya Anti-Doping Agency (KADA). The establishment of KADA enabled Team Kenya to participate in the 2012 London Olympics. However, KADA lacked legal backing hence it was not sustainable. As a short-term measure, His Excellency the

President established the Anti-Doping Agency of Kenya (ADAK) through an Executive Order of November 2015.

The Executive Order was followed by a Legal Notice No.256 of 24th December 2015. Even then all those measures did not meet World Anti-Doping Agency (WADA) requirement of establishing a National Anti-Doping Organization (NADO). Thus the Anti-Doping Agency of Kenya (ADAK) was legally established through an Act of Parliament after the enactment of the Anti-Doping Bill to an Anti-Doping Act, No.5 on 22nd April 2016.

Since its establishment ADAK has reached out to over 25,000 Kenyans through sensitization and awareness campaigns organized through outreach programs and workshops for different groups of athletes and athletes' support personnel, as well as values-based education organized for children under 16 years during holidays and weekends. In addition, over 700 doping tests have been carried out among athletes from various sports disciplines and levels. The Agency has also trained 16 Anti-Doping Educators, 16 Doping Control Officers and 36 Chaperones who work on volunteer basis.

STRATEGIC PLAN LAUNCH

The Anti-Doping Agency of Kenya launched a four-year strategic plan which outlines the activities that ADAK plans to undertake over a four-year period from 2016/17 through to 2019/20.

In the plan, the Agency seeks to undertake various interventions which are estimated to cost USD \$24 million. The rationale behind preparation of the strategic plan is premised on the fact that Kenya is a sporting powerhouse and as such there is need to ensure that the sporting environment is clean, as well as, making sure that the athletes' well-being is catered for.

While launching the Strategic Plan, the Cabinet Secretary for the Ministry of Sports, Culture and the Arts Dr. Hassan Wario lauded

ADAK for coming up with a road map on how it intends to provide Kenyan athletes with a clean sporting environment. The Cabinet Secretary, who is a member of the World Anti-Doping Agency (WADA) Foundation Board, paid glowing tribute to ADAK for taking up the challenge of fighting the doping scourge despite the short time that it has existed.

The Strategic Plan is aligned to the Kenyan constitution and other policy documents such as the country's economic development blueprint, Vision 2030, and the Anti-Doping Act, 2016. In addition, the plan also provides for linkages with other national and international stakeholders with a view to ensuring that ADAK plays its rightful mandate in line with International Standards.

1.3.1 The Agreement is being implemented through the following main elements:

- 1.3.1.1 Project meetings;
- 1.3.1.2 In-between working periods;
- 1.3.1.3 Guidance and support; and
- 1.3.1.4 Exchange of personnel.

1.3.2 The main topics to be covered are:

- 1.3.2.1 Anti-Doping structure;
- 1.3.2.2 Doping control including Athlete Biological Passport (ABP);

- 1.3.2.3 Information and Education;
- 1.3.2.4 Intelligence and Investigations;
- 1.3.2.5 Communications; and
- 1.3.2.6 International cooperation.

So far during this partnership we have had 2 Project Meetings and 3 trainings (Intelligence & Investigations, Results Management and ABP).

Next Project Meeting is scheduled for November 2017 and the areas to be covered will include:

- Information and Education;
- Intelligence & Investigations training for ADAK's key partners involved in conducting investigations.

These trainings have assisted ADAK in building capacity of its staff and in achieving some of the requirements in the WADA Audit Report.

The Anti-Doping Agency of Kenya (ADAK) was at the forefront of promoting a doping-free sporting environment during the International Association of Athletics Federations (IAAF) World Under 18 Championships held in Kenya from Wednesday, 12th July 2017 to Sunday, 16th July 2017.

ADAK, through the Medical and Anti-Doping Sub-Committee of the Local Organizing Committee (LOC) had a major role to play during this global event. ADAK had ten (10) Anti-Doping Educators, divided between two venues of outreach programs. Out of the ten (10), Seven (7) were stationed at the Moi International Sports Centre, Kasarani the venue of the events, while the remaining three (3) joined four (4) Educators from the WADA and the IAAF to operate at the Games Village

which was at Kenyatta University.

The WADA and IAAF Educators plus three (3) from ADAK, were be deployed at the Games Village (Kenyatta University), a venue identified to deal specifically with the U18 athletes.

The seven (7) Educators were deployed at MISC Kasarani Safaricom Stadium where the focus was to reach out to other athletes from all sports disciplines as well as the general public patronizing the stadium as spectators.

ADAK as the Sample Collection Authority for the World U18 Games carried out fifty three (53) in-competition doping tests, and had deployed ten (10) Doping Control Officer (DCOs) and twenty (20) Chaperones for this purpose. IAAF was the Testing and Result Management Authority for the Games.

The World Anti-Doping Agency (WADA) partnered with the Anti-Doping Agency of Kenya (ADAK) and the newly-formed Athletics Integrity Unit (AIU) to deliver its Legacy Outreach Program, during the IAAF World Under 18 Championships in Nairobi, Kenya from 12th - 17th July. The Agency's Legacy Outreach Program, which is delivered during major international sports events, provides additional support to Anti-Doping Organizations (ADOs) in developing and delivering sustainable anti-doping awareness programs. This partnership raised awareness and promoted clean sport to a generation of young athletes, while leaving behind an array of resources for ADAK to use again in the future.

"WADA is pleased to partner with ADAK and the Athletics Integrity Unit to bring the Legacy Outreach Program to young athletes in Nairobi, Kenya," said Olivier Niggli, Director General, WADA. "The Program has proven to be a great way to work hand in hand with our partners in creating global awareness of anti-doping with athletes and their entourage," Niggli continued. "By working together and creating resources that can be leveraged time and time again, WADA's investment has a lasting and meaningful impact," he continued.

"Along with WADA, ADAK believes that raising awareness is the first step to building understanding," said Japhter Rugut, CEO of ADAK. "WADA's Legacy Outreach Program and the knowledge-sharing that this unique partnership brings is greatly appreciated," Rugut added. "The resources developed by WADA for ADAK will be used for this event and many other events in Kenya, in the future," he

continued. "As a complement to values-based education, Legacy Outreach is one of the best ways to curb doping by reaching athletes as early as possible; informing them of the many anti-doping resources at their disposal; and, informing them of the channels they have to voice concerns regarding any doping that may exist within their teams or federations."

"The AIU is pleased to partner with WADA and ADAK at one of the IAAF's biggest events for youth," said David Howman, Chair of the AIU. "At this early stage in their athletic careers, athletes must be fully empowered to know their rights and responsibilities and we are pleased to play our part in this regard."

The Legacy Outreach team, which was made up of members from ADAK, AIU and WADA, was led by athlete ambassadors Tegla Loroupe and Paula Radcliffe. Loroupe, who is a member of WADA's Athlete Committee, is probably best known as the first African female to win the New York Marathon; and as having led the Refugee Team at the 2016 Rio Olympic Games. Radcliffe, a member of the IAAF's Athlete Committee, currently holds the world record in the marathon. Both athletes are vocal supporters of the clean sport movement and have firsthand knowledge of the pressures surrounding doping in sport. The Outreach team invited athletes, coaches and other support staff to take part in fun and educational activities. They were encouraged to complete the Play True Quiz which is now available in 39 languages, to sign the Clean Sport Pledge and to share their thoughts on social media using the hashtag #CleanSport. On behalf of the Athletics Integrity Unit (AIU), Paula Radcliffe encouraged athletes to sign the AIU's Athletes' Pledge, through which competitors can demonstrate their commitment to clean athletics.
