

Azerbaijan as a sporting country shows its highest interest in the fight against doping in sport and promotion of fair play. Azerbaijan became the signatory to the Anti-Doping Convention of Council of Europe in 2004 and International Convention against Doping in Sport in 2007.

As a result of considerable support of the government in sport, conditions for independent, transparent and impartial national anti-doping organisation have been created. Azerbaijan set the single framework towards the monitoring clean sport and established Azerbaijan National Anti-Doping Agency in the last quarter of 2016 as a single authority with the public responsibility for the implementation of the anti-doping policy within the country.

With the increasing scale of global illegal activities in sport and doping frauds, the protection of Azerbaijani sport is crucial and urgent. Past years showed the necessity for keeping the confidence in anti-doping programs and strong governmental regulations at the highest priority.

In this regard, Azerbaijan with its established national anti-doping organisation considers critical to strengthen the anti-doping efforts and foster the fight against doping in sport. With the stable and constant support from the government, Azerbaijan National Anti-Doping Agency is moving forward by increasing its human capital expertise, advancing intelligence and educational capacities, investing in innovative methods and providing strong preventive, deterrent and detective measures against doping violations.

With the environment of having a specific law and independent anti-doping organisation, Azerbaijan National Anti-Doping Agency has relevant authorities and aims to fight for and promote clean sport for the integrity of Azerbaijani sport at both national and international levels.

And our commitment keeps us going forward and leads to actions.





AMADA promotes the rights of athletes and plans the strategy using feedback and views of athletes through empowering programs and services that facilitate their overall growth and development.



National Anti-Doping Structure

AMADA

Azerbaijan National Anti-Doping Agency (AMADA) is the National Anti-Doping Organisation in the country. It was established in December 23, 2016 in accordance with the Law of the Republic of Azerbaijan "On the fight against use of doping substances and methods in sport" and the Decree of the President of the Republic of Azerbaijan on its implementation. AMADA is a public legal entity, which is the type of organisations in the legal system of the Republic of Azerbaijan that is established by the State as a legal person but carries out the functions of public nature.

In accordance with the Law, AMADA is the single authority in the country that is responsible for the implementation and monitoring of the national anti-doping policy within the country. AMADA is the Signatory to the World Anti-Doping Code (Code). Being a Signatory to the Code, AMADA has to comply with the requirements of the Code and respective International Standards.

AMADA's Primary Functions are:

- / to promote doping free sport in order to protect the health and well-being of competitors and the rights of athletes and their support personnel;
- create awareness in order to discourage the practice of doping in sport among the public and the sporting community;
- develop a national strategy to prevent and fight against doping in sport;
- implement provisions of the World Anti-Dopina Code (Code) and ensure the Republic of Azerbaijan complies with all international agreements and arrangements concerning doping in sport to which is a party;
- implement anti-doping activities in the country including the analysis of collected samples in all sports;
- promote and implement the application of various guidelines and international standards in matters related to anti-doping;
- provide information to athletes, athlete support personnel and on the procedures for, and developments concerning the collection and analysis of samples in accordance with the Code and any standards developed by the World Antidoping Agency;
- collect samples from atlethes in accordance with approved guidelines and International Standards, and secure the safe transportation of samples to the laboratories accredited by the WADA for analysis;
- prosecute anti-doping rule violations; cooperate, as well as to share information with relative authorities for the purposes to prevent the use of doping substances in sport and to obtain information about persons related to illegal trafficking of doping substances;
- and execute all steps necessary to comply with and implement the provisions of the Code.

The World Anti-Doping Code (Code) is the core document that harmonizes anti-doping policies, rules and regulations within sport organizations and among public authorities around the world. It works in conjunction with six International Standards which aim to foster consistency among anti-doping organizations in various areas.

Roles and Responsibilities of AMADA as a Signatory to the Code are the followings: to be independent in its operational decisions and activities; to adopt and implement anti-doping rules and policies which conform with the Code; to cooperate with other relevant national organizations and agencies and other Anti-Doping Organisations; to encourage reciprocal testing between National anti-Doping Organisations; to promote antidoping research; and to vigorously pursue all potential anti-doping rule violations within its jurisdiction and to promote antidoping education.

In accordance with the Code, AMADA adopts and implements its national Anti-Doping Rules. These Anti-Doping Rules are applicable to the athletes, athletes support personnel, republic sport federations, as well as other sporting bodies in the country. Republic sport federations, corresponding registered sporting bodies, athletes, athletes support personnel autmatically acknowledge and accept the exclusive jurisdiction of AMADA provided in the Law, and, subsequently AMADA's Anti-Doping Rules are automatically enforceable towards all these entities and persons.


In addition, according to the Law, AMADA is given full authority and exclusivity to execute a comprehensive national antidoping program encompassing areas of anti-doping such as testing, education, research, intelligence and investigations and other activities, which are reflected in the Anti-Doping Rules; as well as to develop programs, policies, and procedures for each of those areas.

Besides the principles that is provided in the Code, AMADA follows the key principles of the fight against doping


highlighted in the Law such as the compliance of the country with its international obligations, rule of law, mutual cooperation of national and international sporting bodies, confidentiality, ensuring rights and freedoms, compulsory doping control and ensuring the integrity and fair play.

AMADA's organisational structure consists of Supervisory Board and Executive Management, which functions operationally independent from its Board, government and sport. AMADA Management is headed by the Chief Executive Officer.

AMADA's Executive Management consists of seven departments responsible for the areas of testing, intelligence and investigations, legal and results management, education, science, media and communications, and finance and human resources. Each department is responsible for the specific area of anti-doping and complies with the requirements of the provisions of the Code and respective International Standards. AMADA has 18 full-time employees and 36 doping and blood control officers, as well as chaperones, who are employed on a contractual basis.




Organizational **Structure**

Supervisory Board

AMADA's Supervisory Board constitutes of seven members from representatives of sport, healthcare, judiciary authorities, National Olympic Committee, National Paralympic Committee, as well as former athlete and the CEO of AMADA.

Supervisory Board has the functions of supervising the assets of AMADA in such manner as best promotes the purposes for which AMADA is established, determining the provisions to be made for capital and recurrent expenditure and for the reserves of AMADA. It functions in accordance with its separate Statute.

Independent hearing bodies

In light of ensuring fairness, impartiality and independence, two separate bodies were established in accordance with the Law of the Republic of Azerbaijan "On the fight against use of doping substances and methods in sport", which are operationally

and institutionally independent from AMADA. These are Disciplinary Committee (DC) as a first instance body and Appellate Committee (AC) as an appeal body.

These Committees have given the authority to hear and determine anti-doping rule violation cases, decide and impose the sanctions in accordance with the World Anti-Doping Code, AMADA Anti-Doping Rules and other applicable international standards.

Independent therapeutic use exemption body

In addition, in order to ensure that athlete's health is properly secured and protected, operationally and institutionally independent body named Therapeutic Use Exemptions (TUE) Committee (TUEC) was established with the aim to grant a permission for athletes of their use of prohibited substances and methods for reasonable and justified therapeutic purposes.

Legal regulations

National anti-doping structure of the Republic of Azerbaijan is based on the Law of the Republic of Azerbaijan "On the fight against use of doping substances and methods in sport", which sets anti-doping system, roles and responsibilities of all stakeholders as well as country's international commitments. Accordingly, AMADA was established as a single authority which implements anti-doping program, adopts and manages anti-doping rules and oversee the whole anti-doping policy within country.

In performing of their authorities, AMADA's Management and its Supervisory Board, as well as Disciplinary, Appellate and Therapeutic Use Exemptions Committees follow the Constitution of the Republic of Azerbaijan, the Law of the Republic of Azerbaijan "On the public legal entities", the Law of the Republic of Azerbaijan "On the fight against use of doping substances and methods in sport", World Anti-Doping Code, AMADA's Anti-Doping Rules, International Standards and their respective Statutes.

In addition, as a governmentally established organisation, AMADA has given the responsibility to follow the requirements of Anti-Doping Convention of Council of Europe and International Convention against Doping in Sport of UNESCO, which were accordingly ratified and accessed by the Republic of Azerbaijan.

Compliance

Global anti-doping system is monitored by the World Anti-Doping Agency (WADA) and in accordance with the World Anti-Doping Code and International Standards for Code Compliance by Signatories.

Additionally, with regard to the country's international obligations, Anti-Doping Convention is monitored by the Monitoring Group of Council of Europe and International Convention against Doping in Sport is monitored by UNESCO Conference of Parties.

As a single and harmonized rule, every signatory or member state has to be in compliance with the Code and International Conventions in order to have the right to be involved in sporting activities at an international scale.

WADA Audit

WADA's primary role as the global regulatory body is to develop, harmonize and coordinate anti-doping rules and policies across all sports and countries, ensure and monitor effective implementation of the Code and its related International Standards.

AMADA as a signatory to the Code, have a number of compliance obligations monitored under WADA's Compliance Monitoring Program. Accordingly, as part of Compliance Monitoring Program of WADA, AMADA was audited, and a formal assessment of Azerbaijan's antidoping program was conducted on 24-25 September 2019.

Maintaining an effective and compliant system at AMADA is vital for achieving its objectives and essential factor for growth. As a result, announced by WADA, AMADA successfully completed an audit and declared fully compliant with the Code and International Standards.

National Testing Program

AMADA delivers testing programme, which is smart, risk-based, intelligenceled and responsive. AMADA conducts a comprehensive in- and out-of-competition testing program to detect prohibited substances and methods taking into consideration scientific advancements, social research, sporting calendar, sports specific physiological requirements, detection windows etc.

Risk Assessment

Risk assessment increases the effectiveness of testing programmes through targeting the right athletes at the right time, determines where resources should be allocated to sand increases the chances of detecting doping.

Test Distribution Plan

AMADA plans and carries out effective, intelligence based and proportionate distribution of tests by establishing Test Distribution Plan (TDP) based on risk assessment and prioritisation.

TDP prioritises appropriately between sports, disciplines, categories of athletes, types of testing, types of samples collected and types of sample analysis.

National anti-doping policy prioritise Olympic sports, certain sports over others due to a greater risk of doping in those sports and greater national interest sports.

In-Competition


In-competition testing is conducted during a sporting event. Every sporting event which falls within the jurisdiction of the Azerbaijan National Anti-Doping Policy may be subject to testing.


In-Competition is the period commencing twelve hours before a Competition, in which the Athlete is scheduled to participate through the end of such Competition and the Sample collection process related to such Competition.


AMADA collects both urine and blood samples as part of its program.

Out-of-Competition

Out-of-Competition testing program managed by AMADA is vital to ensure a level playing field. Whereabouts information is an important tool to locate athletes at any time and to conduct tests on a no advance notice basis, which is a key element of an effective anti-doping program.



Test Distribution Plan

AMADA plans and carries out effective, intelligence based and proportionate distribution of tests by establishing Test Distribution Plan (TDP) based on risk assessment and prioritisation.



Registered Testing Pool

AMADA maintains a Registered Testing Pool (RTP) and a National Testing Pool (NTP) for the purposes of implementing effective doping control.

Athlete selected to be part of the RTP is required to provide whereabouts information and expect to be tested at least three times a year that may be subject to both in-competition and out-of-competition sample collection.

Inclusion of an athlete in the RTP is based on a number of factors such as physical demands, doping analysis statistics, injury, withdrawal or absence from expected competition, returning to a sport from retirement, sudden improvement in performance, behaviour indicating doping, moving to a remote location, athlete reinstatement after period of ineligibility, information from a third party, serving periods of ineligibility or provisional suspensions etc.

Athlete Biological Passport

Athlete Biological Passport (ABP) is the monitoring of selected biological parameters over time that may indirectly reveal effects of doping on the body.

The passport for each athlete contains the results of individual urine and blood tests, a haematological profile consisting of the combined results of haematological parameters analysed in a series of blood samples, and a steroid longitudinal profile consisting of the combined results of steroid levels in a series of urine samples. AMADA is tracking these parameters consistently and this approach allows AMADA to generate individual, longitudinal profiles for each athlete and to look for any fluctuations that may indicate the use of performance-enhancing drugs or methods.

Storage and retesting strategy

AMADA has established a storage and retesting strategy according to the World Anti-Doping Code and AMADA's AntiDoping Rules as one of the tools to protect the clean athletes.

The samples can be stored for retesting based on the risk assessment carried out by the AMADA, which may be based on ABP data, intelligence, laboratory recommendations or any other source of information.

Therapeutic Use Exemptions

AMADA provides administrative support to the Therapeutic Use Exemptions Committee which is composed of independent experts in the fields of clinical and sports medicine.

TUE is a special permission to use a prohibited substance or method for a legitimate medical condition.

Athletes may have illnesses or condition which requires a particular medication. If a substance contained in the medication or the method used appears on the Prohibited List, the athlete must apply for a TUE before starting the treatment. After the TUEC has reviewed the TUE application, athlete may be given authorization to obtain treatment.


Sample Collection Personnel

AMADA Doping Control Officers (DCO) are trained in compliance with the AMADA Testing Policy and Procedure and WADA International Standard for Testing and Investigations.


AMADA established the procedure to ensure that DCOs are adequately trained to carry out their duties. The DCOs that meet all eligibility criteria proceeds to 3-steps training process before examination and accreditation.

Blood Control Officers (BCO) of AMADA have adequate qualifications, mainly the high medical education and practical skills required to perform blood collection from a vein.

There are 18 DCOs, 6 DCO/BCOs and 12 Doping Control Chaperones (DCC) in AMADA. AMADA's DCO team is multilingual, who speak Azerbaijani, English, Russian, Turkish and some DCOs speak Spanish, Polish and German.

European Youth Olympic Festival

European Youth Olympic Festival is held under the patronage of the IOC, and is the pride of the European Olympic Committees with 25 years of tradition. EYOF is the first top European multi-sport event aimed at young athletes aged 14 to 18. There is a winter and a summer edition, which take place in two-year cycles, in odd-numbered years. The EYOF belongs to the European Olympic Committees (EOC).

The event takes place under the Olympic flag, and is rich with Olympic traditions: from the burning flame to athletes' and officials' oaths. It is at the EYOF that many of Europe's inspiring sports stars of tomorrow take their first steps on the international stage. And while some may enjoy EYOF as a stepping-stone to Olympic greatness, all who participate take home friendships and experiences to last a lifetime.

Approximately 3,600 young people and their officials take part in the summer festivals, while there are around 1,600 participants at the winter editions.

The EYOF symbolically unites the youth of Europe in one Athletes' Village. It is a gateway to the Olympic Games, with many medallists having gone on to win medals at an Olympic Games, and gives top young athletes a first taste of what an Olympic event is like, at the same time encouraging more youngsters to practise sport and lead a healthy lifestyle.

The European Youth Olympic Festival (EYOF) was held July 21-27, 2019 in Baku. AMADA acted as a Sample Collection Agency at the EYOF Games.

Around hundreds of AMADA's doping control officers, chaperones and volunteers were involved in the work at EYOF. The doping control was delivered 100%

paperless, on MODOC - platform for paperless doping control.

In addition, within the framework of the festival, AMADA has conducted a series of educational and outreach activities on behalf of European Olympic Committee.

It was the honour for AMADA to contribute to EYOF, since such events strengthen ties between younger generations all over from Europe and provide with opportunities to contribute to shaping the future of the European sport in spirit of integrity and equal rights.

Paperless Doping Control

AMADA switched to paperless doping control since 2018 and use MODOC platform for this purpose. It is a digitalized, fully integrated system to plan, execute and document in-competition and out-ofcompetition controls with state-of-theart encryption and protection for data transmission and storage.

Education and Prevention

Education

AMADA has diverse education programs, which target specific groups of the Azerbaijani sporting community, from elite athletes to the grassroots level, athletes in Registered Testing Pool, coaches, athlete support personnel, doctors and university students. AMADA's education team experts attends training sessions and camps and deliver sport and age tailored seminars and workshops to a group of athletes and their support personnel.

AMADA considers education as one of the cornerstones of anti-doping program and attaches strategic importance to supporting athletes by educating them and raising anti-doping awareness. AMADA's education strategy is shaped by understanding of significance of increased engagement of stakeholders, especially athletes and use of innovative methods.

Besides traditional education activities, such as workshops, seminars, printed handout materials, delivering anti-doping programs for general and higher education students, AMADA also prioritises using new and innovative methods for getting anti-doping message across.

Key Deliverables for Anti-Doping Education Program

- Run an agile and responsive antidoping education program;
- Communicate effectively to build public and partner confidence in clean sport and the role and operations of AMADA;
- Deliver prevention through education activities across the Azerbaijani sport, supported by the development of best practice tools and support services;
- Influence the prioritization of science and research in Azerbaijan, and use all other research, to capitalize on it to increase the effectiveness of anti-doping activities.

Awareness raising

AMADA's Outreach Program is carried out at national and international level sport events. The team provides discussion about the dangers and consequences of doping in an informative and engaging way and allows participants to test their knowledge on anti-doping.

Academic Community

Collaborative Partnership Agreement with Azerbaijan State Academy of Physical Education and Sport

AMADA has partnered with the Azerbaijan State Academy of Physical Education and Sport (ASAPES) to educate master's degree students in sports medicine and rehabilitation about their clean sport responsibilities. This Anti-Doping course is designed for students as well as all other medical professionals that may interact with athletes with emphasis on:

- Prohibited List;
- Therapeutic Use Exemptions and their submission process;
- Dietary supplement products and the risk associated with their use;
- Sample collection process and the rights and responsibilities of the athletes and medical professionals.

Notably, the course also touches other significant areas of anti-doping like the awareness of health and ethical aspects of doping, as well as awareness of helping athletes to shape their attitudes toward clean sport. This course equips athlete support personnel with effective tools to help athletes to make informed and ethical decisions

Key events

Play True Day



Play True Day is dedicated to clean sport and is intended to raise awareness among athletes, the sporting public and others about the global fight against doping. Play True Day was celebrated in Azerbaijan on April 10, 2019 to support clean sport and clean athletes.

A social oriented promo video with local well-known and young athletes filmed by AMADA invokes to all athletes to respect the rules of the game, play fair and stay clean. Another event dedicated to Play True Day was organized with National Cycling Federation, where national team members together with athletes with disabilities united together to show their support for clean sport and fair play.

International Children's Day




Values are major influence on sport behaviour. The values that children have about their sports influence their priorities and determine the direction their athletic and personal lives take.

Intelligence and Investigation

Intelligence

AMADA assesses and processes antidoping intelligence from all available sources, to be used to help deter and detect doping, by informing the development of an effective, intelligent and proportionate Test Distribution Plan, the planning of Target Testing, forming the basis of an investigation into a possible anti-doping rule violation.

Reporting Channels

As an addition to the activities of intelligence gathering, AMADA is set the mechanism for whistleblowers to report any misconduct that they aware of. Reporting mechanism has various secured channels, such as anonymous and protected website section, confidential interviewing during the

investigations of anti-doping rule violations, as well as phone and e-mail communication means. These reporting mechanism helps AMADA for revealing any misconduct related to the anti-doping.

Investigations

In conducting its investigations, AMADA's Intelligence and Investigations Department follow and comply with the World Anti-Doping Code and International Standards, applicable local legislation and conduct its work with integrity and ethics in fair, objective, impartial and in a timely manner.

Implementing specific procedures and mechanisms of investigation methods for the better pursuit of anti-doping rule violations. Educate and raise public awareness to understand the dynamics of doping issues which enables society to take appropriate measures. Highlight the issues around illicit trafficking and encourage conversations among diverse audiences, such as sport, government and law enforcements bodies. Facilitate opportunities for whistleblowers to overcome their predicament and encourage them to assist AMADA. Investigations Coordinate efforts with law AMADA strengthens the public awareness enforcement and regulatory and cooperation with law enforcement, agencies, other anti-doping as well as protects the whistleblowers organisations to share and develop and encourage them to assist in the fight best practices to combat doping. against doping in sport by: Foster linkages and partnerships with national, intra and intergovernmental stakeholders whose aims and objectives are coincide. Promote the whistleblower program and raise an awareness of its effective impact on the fight against doping in sport. Strengthen intelligencesharing platforms.

Illegal Trafficking

Fitness Centres

Doping substances, mainly anabolic steroids, are widely used by the young generation and the sources of such dissemination are those fitness centres that illegally sell PEDs. People are attracted for such use by the fast improvement of their body shapes and considerable muscle gains. However, anabolic steroids are dangerous to health and could have detrimental effect on the whole generation.

AMADA started its investigation project of those fitness centres and continues to collaborate with law enforcement bodies with the aim to prevent such wide dissemination and combat illegal trafficking.

Contaminated Supplement Case

During the investigations of the athletes' antidoping rule violation cases, AMADA revealed a supplement use, which brought significant doubts into its clearness. As a result, the samples of used and unsealed supplements received from athletes, as well as sealed supplement packages of the same brand were collected and sent to the WADA-accredited laboratory for analysis. Laboratory reported a contamination by several anabolic steroid substances. Those substances are strongly influencing substances, illegal trafficking of which constitutes a criminal offence in accordance with local legislation.

AMADA immediately notified all relevant stakeholders, including Ministry of Youth and Sport, Ministry of Internal Affairs and State Customs Committee, as well as all republic sport federations of the dangers of the supplement. As a result, importation of the supplement was stopped, and athletes became aware of the consequences that they could face should they use that supplement.

PEDs Survey

The average young Azerbaijani is aware of the dangers of doping, has a negative attitude to it, but is unlikely to report its use.

This is evidenced by the results of a survey, conducted by AMADA to assess the situation and use the findings to improve quality of delivered services. Random sampling method has been chosen and while survey did not target athletes specifically, since perceptions of more heterogeneous population were needed, enough number of athletes or sportengaged persons were covered.

The study surveyed mainly Gen Z (ages 13 to 18 – 19.6% of responders) and young millennials (ages 19 to 28 – 52% of responders). 48.3% of respondents were students. Only 14.5% identify themselves as professional athletes, 29.5% see themselves as amateur athletes, 21.1% are visiting fitness clubs, and 34.9% are not involved in sports. Total number of respondents were around 700.

Overview of the main outcomes:

Gyms are the main points of access to PEDs


Just about one in seven responders admits that he/she were proposed to use doping substances. 60% of them were approached by gym or fitness trainers. A third of the survey participants believe that they can purchase doping substances in gyms/fitness centres, another third would choose a pharmacy, the last part would turn to social media ads. Survey also revealed quite a high level of awareness of steroids' harm: 45% correctly identified their consequences, while the rest chose one or two side effects.

Relatively high level of sports nutrition/ supplements' risks awareness


Convincing majority does not use any sport supplements and can distinguish them from doping substances (64.8%). 6% see no difference between doping and supplements, and 29.2% are not sure. Three most popular sports nutrition/supplements are protein (26.7%), Omega-3 (11%), and BCAA (6.6%).

General negative attitude toward use of doping substances


The absolute majority (72.8%) believes that it is possible to achieve high results in sport without doping and only 9.7% do not think so. More than a quarter of respondents (26.4%) consider people who use doping to be cheaters.

Results Management Process

Results Management is process encompassing the timeframe between notification of the athlete of potential antidoping rule violation, through the charge until the final resolution of the matter, including the end of the hearing process at first instance or on appeal (if an appeal was lodged).


AMADA's Results Management process is managed by the Legal Department and is governed by the principles of fairness, impartiality and timeliness. The mechanism for the resolution of anti-doping rule violation consists of AMADA's Case Management Commission managed by Legal Department and operationally and institutionally independent bodies of first and appeal instances (Disciplinary and Appellate Committees).


As a general rule, if athlete waives his/her right for a hearing or gives a consent for a sanction proposed by AMADA's Case Management Commission, then the decision-making body is considered as AMADA. Otherwise, if athlete disputes a case, then it is referred to Disciplinary Committee for hearing and decision making with a right of the parties to appeal the decision to Appellate Committee. In cases of international-level athletes, the decision could be appealed to the Court of Arbitration for Sport (CAS) located in Lausanne, Switzerland.


Case Management Commission

Case Management Commission (CMC) is established to take necessary decisions on the possible anti-doping rule violations. CMC has the authority to determine relevant steps that need to be taken for the possible anti-doping rule violations in accordance with applicable AMADA Anti-Doping Rules.

CMC acts in accordance with the Constitution of the Republic of Azerbaijan, the Law of the Republic of Azerbaijan "On the fight against use of doping substances and methods in sport", International Agreements to which the Republic of Azerbaijan is a State Party, Statute of AMADA, applicable World Anti-Doping Code and AMADA Anti-Doping Rules, its Statute and other applicable normative-legal acts.





Legal Aid

The Convention for the Protection of Human Rights and Fundamental Freedoms entails a provision of a proper legal aid if the person who is charged and faced with the possible sanction has no sufficient means to pay for his/her defence. Purpose of the anti-doping proceedings is not to punish, but to make sure that justice prevails, and principles of the clean sport are protected.

One way of balancing requirements of antidoping system with necessity of protecting athletes is to provide athletes with a proper legal aid. In this regard, AMADA initiated a project and approached to the leading law firms in the country.

As a results, AMADA and BM Morrison Partners signed a memorandum of understanding on pro bono legal assistance for athletes whose case will be brought and adjudicated before disciplinary hearing panels. Memorandum entails provision of certain number of pro bono services during a year to athletes who seek a legal assistance for free of charge.

AMADA has strong daily collaboration with the Ministry of Youth and Sport of the Republic of Azerbaijan, as the latter being a body governing the whole sport in the country, is one of the main stakeholders of Azerbaijani anti-doping community.

Law Enforcement Bodies

Doping substances, in particular anabolic steroids, are often imported and distributed illegally on the black market. In this regard, to join efforts for the prevention of such illegal activities, AMADA has set a collaboration with law enforcement bodies and have a Memorandum of Understanding in place. These bodies are Ministry of Internal Affairs, INTERPOL National Central Bureau, State Border Service and State Customs Committee.

National Olympic and Paralympic Committees

Spirit of equal partnership and cooperation with National Olympic and Paralympic Committees are essential in the fight against doping in sport. It is relevant to keep the antidoping system and domestic collaboration at high levels, which inevitably leads that Azerbaijan is represented by clean athletes at international major events, in particular at Olympic and Paralympic Games.

National Federations

Republic sport federations are organisations that govern each type of sport within their respective jurisdiction. In order to jointly fight with doping, as well as promote clean sport and educate athlete and their entourage, AMADA collaborates with all national federations and monitors their compliance with the Code and International Standards.

International Relations

AMADA actively participates on the international scene to promote clean sport. As a national anti-doping organisation, AMADA is always on the lookout for better ways to improve the delivery of its services on domestic level and contribute to the combating doping worldwide. AMADA trusts that mutually beneficial collaboration contributes both on domestic level and on alobal scale.

WADA

The World Anti-Doping Agency (WADA) is an international independent agency composed and funded equally by the sport movement and governments of the world. Its key activities include scientific research, education, development of anti-doping capacities, and monitoring of the World Anti-Doping Code - the document harmonizing anti-doping policies in all sports and all countries. AMADA closely collaborates with WADA on its daily activities and participates on WADA's events and special working groups, which helps AMADA keep the country in compliance with the Code and International Standards, as well as to contribute to the fight against doping in sport globally.

UNESCO

Azerbaijan became a party to the International Convention against Doping in Sport of UNESCO on 23 July 2007. Convention represents that governments around the world have agreed to apply the force of international law to anti-doping. Convention recognizes and helps to ensure the effectiveness of the World Anti-Doping Code (the Code), as well as provides the legal framework under which governments can address specific areas of the doping problem globally.

In accordance with the compliance monitoring of UNESCO, Azerbaijan has set a National Compliance Platform which consists of AMADA, Ministry of Youth and Sport, Ministry of Internal Affairs, State Border Service, State Customs Committee, Food Security Agency, National Olympic Committee, and, accordingly, AMADA being a National Focal Point for domestic coordination of country's compliance.

Council of Europe

Anti-Doping Convention of Council of Europe entered into force on 01 March 1990. The Convention lays down binding rules with a view to harmonising antidoping regulations. Azerbaijan ratified the Convention and its Additional Protocol thereto on 04 November 2003 and 11 February 2004, respectively. Consequently, they came into force in 2004.

AMADA closely collaborates with the Monitoring Group of Council of Europe (T-DO) and Ad Hoc European Committee of the Council of Europe for the World Anti-Doping Agency (CAHAMA) by participating in the meetings and works, as well as its various working groups.

International Testing Agency

On 12 July 2019 AMADA and ITA signed a collaboration agreement. AMADA's partnership with the ITA covers sharing of information and expertise in areas of testing, intelligence, athlete biological passports, and cooperation on other mutually interesting issues. The agreement also envisages AMADA acting as Sample Collection Authority on the ITA behalf, as per request.

Signing of this agreement is a next milestone of development strategy as expansion of international cooperation network to benefit from expertise and ensuring the synergy between national and international anti-doping efforts to bring about better results.

NADOs and Sample Collection Authorities (SCA)

AMADA closely collaborates with other national anti-doping organisations and private sample collection authorities to effectively plan its testing and better exchange of information. In 2019, AMADA signed collaboration agreements with the NADOs of Russian Federation, Uzbekistan, Bulgaria and Moldova, as well as renewed its agreement with the international sample collection organisation PWC based in Germany.

Athlete Engagement

AMADA places special importance on making athlete voices heard, putting it at core of its activities. AMADA fully understands how important it is to involve athletes themselves in fight against doping, engage them in collaboration and enabling them to contribute to levelling the playing field.

Athletes' Advisory Commission

With this in mind, in 2019 AMADA initiated the establishment of the Athletes' Advisory Commission as part of its ongoing efforts to increase the cooperation with the athlete community. Its mission is to discuss various aspects of AMADA's activities and develop recommendations.

The duties of Commission mainly consist of supporting the core mission, leading and managing specific athlete-related projects, serving as a liaison between athletes and AMADA and representing Commission at different anti-doping events. AMADA works together with the Commission on crucial points and emerging anti-doping issues, as well as collaborate to integrate athletes' opinions and needs in its activities.

The Commission will not only be the forum where the voices of the athletes will be heard and represented, but it will be an important body which will advise AMADA in taking further steps for the future development and promotion of clean sport.

Innovations

Innovative Approach

AMADA strives to achieve the synergy of the systems and solutions being used in the sector with the newly available technology breakouts (blockchain based systems, artificial intelligence and prediction systems, machine learning etc.) to increase the loyalty, transparency and trust within the sector between all the stakeholders involved:

- Apply techniques for extracting information from data streams:
- Replace manual assessments with automated algorithms;
- Use Machine Learning to learn from data, make predictions, identify opportunities or dangerous risks;
- Detect arrangements of characteristics or data about a given system or data by pattern recognition;
- Use pattern recognition algorithms for Predictive analytics;

- Continually monitor trends to make timely ch anges;
- ✓ Use outcomes of data analytical process for further research projects;
- Develop an online catalogue of digital tools, which will provide investigation, education, testing departments with userfriendly data they can use to boost Anti-Doping program.

Technological Advancements

Blockchain-based registry

AMADA is creating a unified registry of country's athletes based on blockchain technologies, including athlete database, athlete registration to competitions and anti-doping related database.

The system will store a "digital doppelganger" of each athlete and will contain information not only about the athletes themselves, but also about their coaches and doctors. Using blockchain technology will help to prevent the risk of loss or falsification of athlete data. All personal information about the athlete will be protected by the state-of-art cryptographic algorithms. AMADA plans to launch the registry by the end of 2020.

AMADA is deeply convinced that this project will be a significant step to expanding the use of blockchain technologies to the world of anti-doping as it is an exciting development that promises to change the way we used to work with information.

Blockchain Benefits

Decentralization.

There is no dependency from a single server in the chain. Each participant of the chain is the server. You don't have to worry about data loss, even if some of the computers in the network go down.

Transparency.

Transactions records are stored in the public domain. However, this data cannot be changed.

No limitations.

Theoretically, the blockchain can be supplemented with records to infinity. Therefore, it is often compared to a supercomputer.

Immutability.

In the context of the blockchain it means that once something has been entered into the blockchain, it cannot be tampered with.

iQuiz

AMADA has developed the world's first audio based Anti-Doping Quiz for visually impaired athletes based on WADA Quiz questions.

In line with its pledge to deliver antidoping education to all athletes and placing a special importance on the equal opportunity services, AMADA has developed and presented a special outreach program during the International Blind Sports Federation (IBSA) Judo Grand Prix Baku 2019.

During the outreach program, AMADA's education team presented the iQuiz, inhouse-developed interactive audio-based multimedia Anti-Doping Quiz system for athletes with visual disabilities. The iQuiz can be used as a supporting tool for Anti-Doping learning. Athletes from 34 countries that took part in the event had the opportunity to prove their antidoping knowledge and to be awarded from AMADA.

Hackathon

AMADA seeks to engage innovative capacity of younger generation with outof-the-box ideas and involve them in the fight against doping. AMADA organized hackathon with eight teams of developers and engineers that competed for 48 hours in the incubation, acceleration and research centre, trying to solve two main and two additional tasks. The winning team prepared a prototype, based on which a working product is currently under development. Participation in the competition was open to business creators, students, researchers, entrepreneurs, associations, companies, developers, users, job seekers, designers and domain experts.


