As a non-profit foundation under public law, which has been institutionally supported since January 2020, NADA Germany is an independent body. NADA Germany opposes doping in sports nationally and internationally alike. For the future of sport. For Germany as a sport nation. For clean athletes, for transparent success and honest results.

COMMITMENT TO EQUAL OPPORTUNITY

All activities of NADA Germany are focused on the clean athletes. NADA Germany dedicates its daily work to them. As an institution of clean sport, NADA Germany focused on the development of national and the improvement of international anti-doping work in 2019.

"Operation Aderlass" was a consistent part of NADA Germany's work in 2019. On the basis of the results NADA Germany strengthened its testing programme. Furthermore, NADA Germany optimised the test planning according to current scientific findings. "Operation Aderlass" also provided important insights for our prevention work. We need to ensure that young athletes are prevented from risking their health. To improve the international anti-doping work, NADA Germany collaborated with 19 leading NADOs in 2019, including a meeting with the designated WADA President Witold Banka, and communicated relevant demands. Improvements of the system are also essential in view of upcoming major sporting events. The financing of NADA Germany is the basis for the realisation of all activities. For the first time NADA Germany stands on a secure financial

foundation. We are very pleased with this important signal from Parliament.

"Operation Aderlass" showed how important the introduction of the Anti-Doping Act is for our work. It establishes a basis for cooperation with state investigative authorities to uncover criminal structures in sport. The pillar of the Intelligence & Investigations work is also gaining importance at NADA Germany as it is strengthened in the sports law regulations, the World Anti-Doping Code. The World Anti-Doping Code has been revised in the past two years and was adopted at the World Conference Against Doping in Sport in November 2019. Now the International Federations and the National Anti-Doping Organisations are asked to implement the World Anti-Doping Code 2021.

CONTINUED PROGRESS IN ANTI-DOPING WORK

n the past year of 2019, important foundations were laid for the continuous improvement of anti-doping work in Germany. Financial security is important in the long-term in order for NADA Germany to carry out all tasks stipulated in the constitution of their foundation and to ensure that NADA Germany can continue and expand its successful work - for pure performance. However, it should also be mentioned that the stakeholder model envisaged during the foundation of NADA Germany has not been achieved. The German Bundestag has recognised NADA Germany's central role in anti-doping work and ensures medium and long-term institutional funding. As of January 2020, the financing of NADA Germany as a stakeholder model was largely replaced.

NADA Germany is responsible for creating the conditions for doping-free sport in Germany. The two pillars – prevention and testing – contribute significantly to upholding values in sport. The prevention programme financed by Germany's federal and state governments "TOGETHER AGAINST

DOPING" represents a main area of focus for NADA Germany. The reason for this is that this area reflects a broad socio-political and social responsibility of the foundation. After all, the greatest objective is to prevent doping and enable fair sporting conditions.

The second pillar of an effective anti-doping work represents the successful execution of a cohesive testing programme in Germany. To protect clean athletes, NADA Germany organises a high, but appropriate number of controls outside of competitions as well as within.

The Intelligence & Investigations work plays another key role within NADA Germany. The criminal structures which were uncovered in the "Operation Aderlass", show that Germany has taken the correct step with the Anti-Doping Act which has been in force since 2015.

The Olympic and Paralympic Games in Tokyo (Japan) have been postponed until next year. NADA Germany had already started to educate the German athletes and their environment in advance, to

organise the signing of the declaration of honour of all individuals involved and to conduct further tests in the framework of the pre-Olympic testing programme. These preparatory measures will now be resumed for the 2021 Games.

The global demand for improvement of anti-doping work in the sense of comprehensive equal opportunities highlights the importance of NADA Germany's operations on the national as well as international level. Ultimately, not only fair competition is on the line but also the health of our athletes.

The membership on NADA Germany's Supervisory Board means to be responsible for the values of sports and to ensure the future of NADA Germany as an independent, transparent and a conflict of interests free acting institution.

TESTING PROGRAMME

In 2019 the focus of NADA Germany's testing department was the continued development of the testing programme, based on the findings from "Operation Aderlass", as well as new (sport-)scientific results.

Findings from "Operation Aderlass"

"Operation Aderlass" shows that the state of development of the testing programme is advanced to such an extent, that more and more effort is required by athletes and their support personnel to manipulate. The results from "Operation Aderlass" have led NADA Germany to carry out blood tests directly prior to competitions. Furthermore, the number of controls analysed for haemoglobin-based oxygen carriers (HBOCs) and human growth hormone (hGH) continues to increase. NADA Germany also suggested to the World Anti-Doping Agency (WADA) to include the testing of both arms for haematoma as a change of regulations and to consider the presentation of blood data in ADAMS and the timely access for athletes.

Long-term storage and re-analysis

NADA Germany has increased its long-term storage programme. Since

2019 approximately 3,000 samples are put into long-term storage annually in order to be able to re-analyse these samples with improved analysis methods for up to ten years after sample collection. In 2019 NADA Germany re-analysed all samples from 2013 to 2015. The samples were tested for myo-inostiol trispyrophosphate (ITPP), transgenic RNA (siRNA) for the detection of gene doping, selective androgen receptor modulators (SARMs) and growth hormone releasing peptides (GHRPs). All samples were negative.

International exchange

For the second time, NADA Germany invited experts from National Anti-Doping Organisations (NADOs) for an exchange of expertise in doping control planning to Bonn, to interchange on scientific findings as well as current topics within control planning. Employees of NADA Germany's testing department attended

in various conferences, including the expert meeting on the Athlete Biological Passport (ABP) in Copenhagen or gave a lecture about the NADA testing programme in Bristol, England.

LEGAL MATTERS

In 2019 the preparation to revise the World Anti-Doping Code 2021 (WADC2021), "Operation Aderlass" as well as the execution of results management and disciplinary proceedings encompass the main area of responsibility for the legal department.



World Anti-Doping Code 2021

The World Conference Against Doping in Sport was held in Kattowitz (Poland) in November 2019 during which WADA adopted the WADC2021. After WADA's two-year revision process, the International Federations and NADOs are urged to integrate the WADC in the national anti-doping legislations. In Germany the legal department takes on the responsibility of applying the WADC into the National Anti-Doping Code (NADC2021). The International Standards were also adapted. NADA Germany contributed to in the formulation of the International Standard for Results Management.

..Operation Aderlass"

Immediately after the ARD documentary "Die Gier nach Gold – Der Weg in die Dopingfalle" (The Greed for Gold - The Road into the Doping Trap) was broadcast in January 2019, NADA Germany filed a criminal complaint against unknown with the responsible public prosecutor. NADA Germany supported the subsequent investigation into "Operation Aderlass" and followed up all evidence



from the investigation results indicating violations against sports law. NADA Germany's investigations and a whistle-blower tip led to the initiation of proceedings against a former top German athlete before the German Sports Arbitration Court in May 2019. The proceeding is pending.

The criminal structures uncovered so far show that Germany has taken the right path with the Anti-Doping Act.

NADA Germany will therefore continue to work closely with public prosecutors.



Results Management and Disciplinary Proceedings

In 2019, 82 results management procedures were initiated due to possible anti-doping rule violations. NADA Germany has initiated disciplinary proceedings in 24 cases before an Arbitration Court during the reporting period. Eight of these proceedings resulted in sanctions up to the editorial deadline. In 24 of the cases listed above (plus seven informational notices), NADA Germany filed a report with the public prosecutor.

INTELLIGENCE & INVESTIGATIONS

In 2019 the focus of NADA Germany's Intelligence & Investigations work was on networking and the exchange with the various partners in order to determine possible anti-doping rule violations.

Strengthening of the global network

At the invitation of WADA in March 2019, 17 international experts from the Intelligence & Investigations work of seven NADOs, two International Federations and INTERPOL participated in an exchange in Bonn. This exchange was part of the cooperation with Günther Younger and his team. The meeting organised by NADA Germany addressed the expansion of the global network, possibilities for future networking and current methods in investigation.

Joint exchange with state investigative authorities

The investigation work as part of ...Operation Aderlass", new analytical developments in the area of the two German WADA-accredited laboratories in Cologne and Kreischa, as well as an update from NADA Germany's testing department were on the agenda of the joint meeting in Bonn with the state investigation authorities in May 2019. The content focused on intensifying

cooperation, as well as on a comprehensive exchange of experiences by all involved parties.

Workshop for investigation officials

Around 30 prosecutors and investigators from customs, the Federal Criminal Police Office, the State Criminal Police Offices and individual police departments attended the fifth one-and-a-half-day workshop for investigative officials in November 2019. The meeting objective was to strengthen joint action and to increase the effectiveness of the anti-doping work in all areas.

MEDICINE

The focus of the medical department includes responding to inquiries regarding medication, the expansion of education sessions for doctors, medical specialists, and pharmacists as well as the assessment of applications for Therapeutic Use Exemptions (TUE).

Training and information

The medicine department offers phone consulting hours from Monday to Friday for doctors, pharmacists, physiotherapists, and medical support staff, during which a total of 1,072 inquiries were answered in 2019. The department also continues to publish the German translation of the WADA Prohibited List. the "Example list of permitted medicines", as well as the "MediCard". Lectures across Germany rounded off the offering of the department. Among other events, the staff held lectures at the Medical Conference of the National Paralympic Committee, the professional training of the Hessian Chamber of Pharmacists in Gießen with around 300 participants, and at the medical and physiotherapist meeting of the Rhineland Olympic Training Center (Photo: f.l.

Daniel Müller (OSP Rheinland), Prof. Dr. Bernd Wolfarth (DOSB), Dr. Anja Scheiff (NADA Germany), Prof. Dr. Hans-Georg Predl (DSHS Köln), Dr. Thomas Schramm (DGSP)). For the first time, the medical department organised a webinar for the doctors and physiotherapists of the Snowboard Association Germany.

Flyers on the subject of infusions

The anti-doping regulations regarding the distribution of intravenous infusions are complex. The medical department created an information flyer in order to support medical staff as well as athletes and to compile the most important information on the topic of infusions.

D-A-CH Medical Experts Meeting

The frequent information exchange of experts from the German-speaking anti-doping organisations from Germany, Austria and Switzerland, which operate under the acronym D-A-CH, offer high efficiency for all parties. In September 2019, the central focus of the group's meeting was the implementation of WADA requirements, during which special attention was given to the regulations for TUEs.

PREVENTION

Prevention measures are a focal point of NADA Germany's work. They reflect the broad socio-political and social responsibility of the foundation. Ultimately, the primary goal is to prevent doping and to enable fair sport.

Deepening of behavioural prevention

The future standard for the implementation of preventive measures in anti-doping work will be the WADA International Standard for Education, which was adopted in November 2019 with the WADC2021. The conveying of values is the central focus of the educational approach. Ethical decisionmaking and moral behavioural training are already an integral part of NADA Germany's training courses with young athletes and their environment. The focus of the workshops lies on the core values of clean sport, in which athletes are encouraged to reflect on their behavior in simple decision-making situations. This approach is also implemented in the other behavioral prevention measures that are part of the "TOGETHER AGAINST DOPING" prevention programme. This includes for example the online platform and brochures.

Development of environmental prevention

The prevention programme and in particular the accompanying stance must be supported and implemented by the structures of sport. The funding guidelines for anti-doping measures have been adjusted accordingly. The German national sport organisations are obliged to actively implement doping prevention measures in their area.

For the third time, NADA Germany and the Federal Institute for Sports Science invited representatives of national sport associations, state sport associations, regional associations, large clubs and other institutions related to doping prevention to the RheinEnergieSTADION in Cologne for the further expansion of environmental prevention. The focus of the two-day "TOGETHER AGAINST DOPING" network event was to develop a strong network with the aim of protecting young athletes from doping.

Information for coaches

Coaches are among the most important parties in the sporting environment of an athlete. This comes with a special responsibility. Coaches play a key role in supporting athletes to achieve sporting success through clean performance. They are therefore an important contact for NADA Germany's prevention programme.



Preparation for the Youth Olympic Games 2020

All German participants of the Youth Olympic Games (YOG) 2020 in Lausanne (Switzerland) were made familiar with the anti-doping regulations in the run-up to the Games. The familiarisation was carried out through the "TOGETHER AGAINST DOPING" prevention programme and with the NADA Germany's e-Learning platform in cooperation with the German National Olympic Committee (DOSB).



On-site events

For the first time, various German national championships were carried out simultaneously at the FINALS in Berlin in August 2019. NADA Germany educated participating athletes in the run-up and was on-site for questions and available for exchange on different topics.



Research projects

The further development of doping prevention in Germany is an essential part of NADA Germany's work. Therefore, NADA Germany is involved in a variety of research projects such as "The development and evaluation of a value driven doping prevention program in young athletes" of Leipzig University. Events for teachers

In cooperation with the German Olympic Academy (DOA), NADA Germany offered teacher trainings in association with the prevention programme "TOGETHER AGAINST DOPING" under the motto "Olympic – Fair – Clean". In mid-September around 50 teachers across Germany from different school systems from the education-competitive sport network took part in the event in Frankfurt.



Freelancers

At the end of March in Cologne, NADA Germany trained its freelancers who support NADA Germany with the prevention programme "TOGETHER AGAINST DOPING" at schools and competitions.



COMMUNICATION & MARKETING

The focus of the communication & marketing department was responding to requests, annual press conferences, the informing of journalists, international exchange, as well as different events associated with the initiative "GIVE EVERYTHING. TAKE NOTHING".







Public relations

NADA Germany once again provided information about its work in 2019 through daily media inquiries and the interested public, as well as interviews and press conferences. The focus of the annual press conference in Berlin in June 2019 was the presentation of the annual figures, an overview of the past anti-doping work of NADA Germany, as well as an assessment of current national and international anti-doping topics. At the journalist workshop in October 2019, Steffi Nerius (Head of the Leverkusen Sports Boarding School and javelin world champion), Senior Prosecutor Kai Gräber (Munich I Public Prosecutor). Michael Ask (Anti-Doping Denmark. INADO) and Dr. Lars Mortsiefer discussed the topic "Intelligence & Investigations - Anti-Doping 2.0?". NADA Germany has been gradually adapting its training concept for journalists since the end of 2019 based on the results of the study "Knowledge and attitudes of sports journalists in Germany on the topics of doping and doping reporting" conducted by Prof. M. Schaffrath and his team from the Technical University of Munich. For the first time, international anti-doping communication experts met for an exchange in Bonn at the invitation of NADA Germany and discussed the different strategies and communication methods.

Clean sport initiative

"For the future of my sport" - this is what fencer Alexandra Ndolo is committed to as part of NADA Germany's photo campaign in 2019. Featured are also beach volleyball player Clemens Wickler and gymnast Lukas Dauser, who highlight the importance of clean sport with their statements. In the first NADA Germany YouTube format, two athletes from different sports and disciplines, or from different squad status, meet under the title "CHANGING SIDES". They exchange ideas about their sport,

their experiences and the values that they associate with their sport. With the booth for the "GIVE EVERYTHING, TAKE NOTHING" initiative, NADA Germany 2019 once again provided a platform at various events to promote clean sport.

HUMAN RESOURCES, FINANCES & CONTROLLING

The focus of the HR, finance & controlling department in 2019 was the transition into the new form of financing of institutional funding.

Financing

The financial year 2019 ended with a positive result of approximately 340,000 Euro. The predominant NADA Germany funding from the federal government and sport compensated for the lack of financial support from the private sector. For the first time, the sport federations contributed the announced 1.5 million Euro in full.

The federal government contributed with 4.4 million Euro to NADA Germany's operations. The federal states added a joint total of 500,000 Euro to the financing of doping prevention. Sport

contributed with 3.1 million Euro.
The total operating business budget
amounted to around 10.7 million Euro.
Included are federal funds of around
2.3 million Euro, which financed research
and analysis activities of the WADAaccredited laboratories in Cologne and
Kreischa.

In 2019, an area of focus was the transition to the, for NADA Germany, new institutional funding model by the federal government. Since January 2020, NADA Germany receives institutional funding.

External auditors

The work of NADA Germany is monitored annually by various authorities. Already in 2018, NADA Germany was certified in accordance with DIN EN ISO 9001 in the scope of "Promotion, implementation and coordination of anti-doping work in Germany by means of suitable sports science, educational, social, medical and legal measures". The first surveillance audit was successfully completed in 2019. Furthermore, the annual financial statements of NADA Germany are audited annually by an external auditor. This review resulted in no objections for 2019.

Human Resources

As of 31.12.2019, NADA Germany employs 32 full-time employees, seven part-time employees and six marginal employees.

Property Administration

The rent of the new property at Platz der Vereinten Nationen 7 assisted in relieving the intensifying issue of space. In the first quarter of 2019, a portion of NADA Germany employees moved to this new office location.

Revenues

In 2019, the federal government made a contribution of an approximate 4.4 million Euro to NADA Germany's operations. Furthermore, NADA Germany forwarded federal funds worth 2.3 million Euro to the German WADA-accredited laboratories. Sport supported NADA Germany's financing with an approximate 3.1 million Euro, and the federal states contributed to doping preventative measures with a total of 500,000 Euro.

INTERNATIONAL COOPERATION

The focal point of international cooperation was building a network of individuals responsible for anti-doping work in order to improve equal opportunities globally.



International exchange

The cooperation with other NADOs is important in order to create equal opportunities for athletes worldwide. To ensure that appropriate requirements have been met, NADA Germany is a member of the NADO Leaders Group, which met on three occasions in 2019 to discuss the current situation of anti-doping work and to establish demands regarding system improvements. This also took place in connection with the still open decision regarding the consequences of the doping and manipulation scandal in Russia. Another aspect of this work is the direct exchange with individual NADOs. This included the various meetings in 2019 with the Germanspeaking anti-doping organisations from Switzerland and Austria in all areas as well as with the Dutch anti-doping organisation in the area of prevention.



International conferences

In 2019, NADA Germany took part in various anti-doping conferences for exchange but also for the acquisition and transfer of knowledge. NADA Germany used the World Conference on Doping in Sport in November 2019 in Katowice (Poland) as an opportunity to intervene before the revised WADC was adopted (Photo: f.l. Dr. Andrea Gotzmann (NADA Germany), Witold Banka (WADA)). Dr. Andrea Gotzmann gave a lecture entitled "Operation Aderlass" - Cooperation with law enforcement agencies" at the Science Symposium of the American Anti-Doping Organisation USADA in October 2019. Furthermore, NADA Germany took part in the Play the Game Conference in October 2019 in Colorado Springs (USA), at which the NADA Germany CEO presented the establishment of the Anti-Doping Act since 2015 and its impact in Germany. The visit to the Education Summit in



March 2019 in the USA served to improve prevention work worldwide (Photo: from left Prof. Mario Thevis (DSHS Köln), Dr. Andrea Gotzmann (NADA Germany), Dr. Detlef Thieme (IDAS Dresden)). NADA Germany contributed to the WADA symposium in March in Lausanne (Switzerland) and to the WADA conference on the Athlete Biological Passport in Copenhagen (Denmark) in November 2019.

International bodies

NADA Germany is actively involved in various committees for effective and sustainable conditions in international anti-doping work. In March 2019, Dr. Lars Mortsiefer was appointed to INADO's Supervisory Board. He is also the Chairman of the Advisory Group on Legal Issues of the Monitoring Group in the Council of Europe, which submitted relevant change proposals for the WADC2021 in 2019.



Exchange with colleagues from Japan

In the run-up to the Olympic and Paralympic Games in Japan, the Japanes Anti-Doping Agency JADA and NADA Germany met three times in 2019. Two meetings took place in Bonn on the topics of test planning, Intelligence & Investigations work, and prevention and communication work (Photo: f.l. Dr. Lars Mortsiefer (NADA Germany), Nao Nakamura, Saori Ueda, Yuko Hasegawa (all JADA)). A third meeting in Tokyo (Japan) took place for an exchange on the fundamental strategic direction of NADA Germany and current issues regarding the postponed 2020 Olympic and Paralympic Games.



WADA visit in Bonn

In September 2019, Sébastien Gillot, WADA Director European Office and International Federation Relations, and Florence Lefebvre-Rangeon, WADA Senior Manager Government and NADO Relations, were guests at NADA Germany in Bonn. The agenda of the meeting was above all the exchange with the individual NADA Germany departments.



Partner programme with Kazakhstan

In 2019, NADA Germany continued the partner programme with the Kazakh Anti-Doping Organisation. The main focus was on the exchange of knowledge and experience to establish an effective prevention programme and support for the establishment of an independent control system. In addition to NADA Germany's CEO Dr. Andrea Gotzmann and the head fo NADA Germany's prevention department, Thomas Berghoff, the head of the Institute for Doping Analysis and Sport Biochemistry in Kreischa near Dresden, Dr. Detlef Thieme, participated in a joint visit to Almaty (Kazakhstan) (Photo: f.l. Summary

Hereby I certify the existing data protection management system according to the requirements of the valid Federal Data Protection Act 2018 (new) and the General Data Protection Regulation (EU-DSGVO / GDPR) as an externally appointed data protection officer of the National Anti Doping Agency of Germany.

The National Anti Doping Agency of Germany has undergone an admission based on the BSI Basic Protection and has implemented the recommendations.

Specifically the following areas will be implemented in the DSMS data protection management system:

Data protection in Germany

In 2019 the first nine figure fine was imposed in the UK. In Germany, fines have reached eight figures. The actual pressure arises in particular from compliance requirements by clients. Still, data protection remains insufficiently organized for a number of external data processors. Data protection is increasingly becoming a competitive factor.

On the 25th of May 2018, the National Anti Doping Agency of Germany implemented the new legal requirements

NADAjus database

NADA Germany's database NADAjus for the administration of sensitive and particularly worth protecting data on the legal basis of the WADC and the NADC derived from it in connection with the Anti-Doping Act did not show any disturbances, conspicuities, erroneous accesses or even data losses in the reporting period.

The use and publication practice is carried out in close coordination with the responsible data protection supervisory authority on the part of NADA Germany.

Procedure log

Up to this point, conform to DSGVO Art. 30 procedure directories have been created in the following areas:

- IT
- Administration / secretariat
- Accounting department
- Office communication / office / writing department

Further process directories are being created. Existing process directories are maintained continuously.

Fulfilment of information duties

The data protection information for websites and portals has been adapted to the requirements.

Data deletion policy

Data is deleted or blocked after the legal basis has ceased to exist or after a consent has been revoked, depending on the technical possibilities. Deletion instructions can also be found in the procedural indexes.

To a large extent, the implementation of deletion is yet to be organized.

Rights of data subjects

The appropriate information procedure has been prepared, the process has been established and the template for possible requests for information has been drawn up.

No requests for information have been received up to this point.

Data security incidents

There were no reportable data protection incidents or IT security incidents in the reporting period.

Order processing agreements

All relevant service providers within the meaning of contract processing pursuant to Art. 28 GDPR were contractually fixed and randomly inspected. The technical and organizational measures pursuant to Art. 32 of the GDPR were examined and approved as a minimum guarantee of compliance with the accountability obligations pursuant to Art. 5 of the GDPR.

Providing training

The organization's management highly values the annual data protection employee sensitization (BDSG, TKG, EU GDPR) to comply with the accountability obligations pursuant to Art. 5 of the GDPR.

Prior data protection checks of essential processes

The data protection officer will be requested if necessary, for example:

- Infrastructure enhancements
- Operation of IT solutions
- Data protection requests from athletes
- Data protection requests from employees
- Data protection requests from other third parties

Information security

The responsible body was subjected to a BSI basic protection audit and recommendations were implemented. NADA Germany has appointed a neutral external IT security officer. Additionally, in October 2019 an internal information security officer was qualified and tasked to meet the requirements.

In the reporting period, there were no relevant IT disruptions or violations of information security


Training and evidence of specialist knowledge of the data protection officer


Perspective
