Dear colleagues and supporters!






ORGANIZATIONAL STRUCTURE










Young Kazakhstani athletes take part in the initiative of the Japanese Anti-Doping Agency "i-Play True Relay".



In 2020 **106 seminars and lectures were conducted, 5481 participants** took part.




