

ADMINISTRATIVE STRUCTURE



Administrative Structure of DCAT

Doping Control Agency of Thailand (DCAT) was established under Section 18 of Anti-Doping in Sports Act B.E.2555 with the aim to perform and conduct its duty as a department of Sports Authority of Thailand in accordance with authority rule, regulation and policy determined by Anti-Doping in Sports Committee in order to gain success and achievement along with alignment to WADA rule and regulation

The agency consists of 2 divisions and 4 working sections i.e.;

1. Anti-Doping Control Division

1.1 Testing Section

The main task of this unit is to conduct testing arrangement, starting from sample collection and ending at WADA accredited laboratories around the globe. This section, therefore, has to learn and know how to conduct collection process properly in order to ensure equity and fairness in any of sports competitions and sports events. Apart from this duty, it is important for this section to keep contact and communication with concerning organizations both national and international.

1.2 Legal Section.

This section is in charge of controlling and result managing in order to ensure quality and efficiency of controlling the use of prohibited substance to be conformed with WADA Code. In addition, it is necessary not only to keep contacting with other organizations e.g. sports associations/federations both local and international, but to create database for athletes who have been found positive and must be punished in accordance with rules and regulations also.

2. Administration Division

2.1 Secretary section

This section is basically responsible for general affairs, administrative activities and all meetings of DCAT committee including to support role and activity of special committees. In addition, it is necessary for the section to make an annual report for the year 2018 in order to comply with Thailand Anti Doping Act and WADA Rule.

2.2 Education Section

Activities of this section is to make a plan and programs for knowledge propagation of the agency by applying various methods e.g. out reaching program during competitions and sporting events, doping control courses arrangement for sport personnel. Therefor this section has to update all doping information by contacting and exchanging for current situation of doping control education with international organizations such as WADA, WADA Asia and so on.



Besides, they had planned and discussed on possibility to send Thai DCAT officials to come to JADA for more learning and studying the progress of doping control management from JADA in both regional and global levels.

7.2 The second one had been arranged during 2 – 9 June 2019 at U.S. ANTI-DOPING AGENCY: USADA in Colorado Spring. The aim of this tour was to study how USADA became the most leading in doping control unit with effective human resources management with up-to-date technology applying in its program.

Conclusion

The both study tours were undoubtedly very useful and fruitful. The group had gained new vision with awareness on how the importance of doping control was in order to achieve integrity and fairness in all sport competitions and without cheating. Eventually there should be integral working in international level by exchanging ideas, technologies and methods together for getting rid of doping in sport.

CONCLUSION AND RECOMMENDATION FROM EACH SECTION

1. Legal Section

1.1 Analytical examination for prohibited substances in contaminated food supplements or drugs taken by athletes without knowing there are banned substances.

Problem The athlete ,who is tested positive for prohibited substances, claims that the detection is the result of taking supplements or drugs to treat illness without knowing that it contains banned substances. Athletes are required to submit the proof for defending by sending samples of those supplements or drugs to the Department of Medical Sciences which requires a period of time and costs for analysis.

Solution There should be a memorandum of understanding (MOU) for the analytical examination of contaminated substances in food products, supplements or drugs.

1.2 The Members of the Appeal Committee

Problem

The arrangement of convening date in order to determine the date of the Appeal Committee's meeting, since there are currently 5 members of the appeal committee consisting of 1 medical committee member, 1 sport committee member and 3 legal committee members, but according to the Announcement of the Anti-Doping Control Board on Appeal Procedure of 2557 B.E. (2014 A.D.),Article 3 determines that in the meeting of the Appeal Committee, there must be at least one member of medical expertise, one of legal expertise and one of sport expertise to be present, so because there is only one member from the medical and sport expertise and in case of one of them could not be able to attend the meeting, then the meetings would not happen. So it is difficult to set up a meeting date.

Solution To revise the order of appointment up to a total of 7 members for Appeal Committee, consisting of 2 for the medical committee members, 2 for the sports committee members and 3 for legal committee members for the convenience of convening. As such if any committee member is unable to attend the meeting, there is still another committee available to attend the meeting.

1.3 Giving the athletes an appellate right at Appeal Committee.

Problem The Anti-Doping in Sports Act, B.E. 2555 (2012) ,Article 27 by giving the right to athletes who are not satisfied with the punishment order of the Punishment Committee can appeal the order to the Appeal Committee. Despite the athletes has accepted their intention to use banned substances to gain any advantages. And the substances detected are related to the type of their sport and they enhance their performance. Therefore there are no other facts or any new facts to be raised in order to reduce the penalty in the Appeal Committee. In addition, there is no reason to reduce any penalties for athletes who intend to use banned substances in order to gain sports advantage.

Solution By the amendment of the Anti-Doping Control Act B.E. 2555 (2012) with additional detail for scrutinizing in order to accept or reject the appellate prior to submit to the Appeals Committee's meeting.

1.4 Interpretation of the documents sent to WADA.

Problem On the occasion of WADA has regularly followed up the operation regarding the detection of positive in athletes under the supervision of DCAT. Therefore all relevant documents should be in English before sending to WADA. Solution Translation fee is needed.

1.5 To which events are sanctioned athletes not allowed to participate in?

Problem Due to the case that the athlete filed a lawsuit to the Administrative Court contending the Sports Authority of Thailand's order that the punishment for not participating in any sporting event is unclear.

Solution Clearly announcement of sports events participation banned

1.6 Publication of WADA CODE in Thai Version

Problem WADA CODEs of 2015 in Thai version are insufficient for the need of use.

Solution The additional publication is needed.

2. Testing Section

2.1 In-Competition Testing Distribution Plan [In-Competition TDP]


Problem National Sports Associations did not provide the proper competition program in advance, it cause DCAT can not prepare the in-competition testing plan to implement effectively.

Solution Communicate with Elite Sport Developing Department at SAT to provide the proper competition plan which the national sport associations send to them for budget approval to DCAT in advance each year for more effective In-Competition TDP

2.2 Lack of Doping Control Personnel

Problem Limitation of Doping Control Personnel (both DCO and BCO)

Solution Conduct more the DCO and BCO training course to the each reginal part by recruiting from the personnel from University which have the Sports



3. Education Section

3.1 Education Activities (Clean Sport 2019)

Problem Unable to cover the numbers of specified target which indicated in the Education Plan because some of the athletes and ASPs have not been training or staying within the country or they frequently have to participate in the competition in other countries.

Soluton We have implemented the on-line Face to Face for this group of attendants.

3.2 Documentation and Leaflets

Problem The documentations and Leaflets could not reach all of targeted athletes and ASPs.

Solution Increase on-line channels to broaden the Education content such as software or application that can be used via cellular phone and tablet.

3.3 DCAT website (www.dcat.in.th)

Problem The website is not up-to-date and less user friendly, lack of some functions such as the function for athlete to submit TUE for more where abouts.

Solution Reimplement the website to modernize it and to reach users expectation. Add more functions so that athletes can submit the concerned documents to DCAT and in line with WADA code.

3.4 System for Thailand Anti-doping Management (STAM)

Problem The output of some modules are not cover all the functions. The report system need to be modified to meet user requirement.

Solution Justify the system to support all the required functions.

3.5 Educator

Problem Insufficient staffs and inadequate knowledge about Anti-doping experience and also the training skill.

Solution - Encourage and support them to get the training and workshop courses and also The opportunity to learn from the expertise of other NADOs.
 Organize the monitoring process to improve the outcome.

- Enhance the partnership with related sports organizations such as Sports Association of Thailand, Provincial Sports Association and Sport University to gain qualified external educators.
